This law firm has been retained to represent the Clay Hotel Partnership, LTD. (the "Applicant"). Please consider this letter the Applicant's letter of intent in support of a Certificate of Appropriateness for Design before the City's Historic Preservation Board ("HPB") required for the redevelopment of the Property.

<u>Background.</u> The Applicant is the owner and operator of the Clay Hotel located at 1434 Washington Avenue (the "Property"). The Property consists of a historic hotel, which was originally constructed in 1925. The Property is within the Espanola Way Historic District and the CD-2 Zoning District.

<u>Proposed Development Program.</u> The Applicant seeks to renovate and remodel the historic Clay Hotel, and return it to its original name The Espanola Hotel. While not adding any additional height or massing to the buildings, the proposed development program will include a renovation of the lobby area to allow for a more functional use of the space and improve the guest arrival experience. Additionally, courtyards will be created to allow for guests to congregate within the hotel.

Other notable additions include the refinishing and painting of the buildings to recreate the feel of a true Spanish village, which was the inspiration for the original hotel and the Espanola Way Historic District. Awnings and ironwork will be used throughout to continue the rustic feel for the historic hotel. Within the interior of the structure, the existing corridors, which are open to the sky, will be covered with landscaped trellis materials to help deflect some of the heat and provide a more intimate experience within the Property. A rooftop deck will be added, which will include a bar area, lounge seating, a relaxation spa pool and other passive areas for use by hotel guests and their invitees.

Finally, the Applicant would like the board to consider the proposed projecting sign on the northeast corner of the hotel building. The sign is proposed to be located above the ground floor and would this require a variance for its relocation. Additionally, a variance is being requested to permit unit sizes below the minimum required unit sizes for hotel rooms in the CD-2 Zoning District, in order to preserve the existing hotel room unit sizes. Finally, a variance is also being requested to the required rear setback. This last variance is needed to provide for some roof protection and improvements on the accessible roof decks. It does not encroach into the rear setback any more than the existing building. However, it simply follows the existing rear building line, as depicted in the plans.

<u>Satisfaction of Hardship Criteria</u>. Section 118-353(d) of the City's Code sets forth the hardship criteria for a variance request. The Applicant's requests satisfy all hardship criteria as follows:

(1) Special conditions and circumstances exist which are peculiar to the land, structure, or building involved and which are not applicable to other lands, structures, or buildings in the same zoning district;

The building is a contributing historic building and the envelope is being substantially preserved and improved. The unit sizes proposed to be retained are for existing hotel rooms, and the sign is proposed to be relocated to allow for pedestrians and guests to locate the hotel's general entrance from a distance, particularly the corridor to the west. The rear setback variance is being requested to continue the existing building line of the rear with the accessible roof deck.

(2) The special conditions and circumstances do not result from the action of the applicant;

The Applicant is attempting to renovate the Property in a way that will provide for a successful hotel development, while maintaining the historic character of the structure. Further, the Applicant is restoring much of the historic elements of the building. In doing so, the Applicant is requesting these variances in order to proceed with the requested use and also retain the existing building envelope.

(3) Granting the variance requested will not confer on the applicant any special privilege that is denied by these land development regulations to other lands, buildings, or structures in the same zoning district;

Granting the requested variances will enable the Applicant to continue to develop the structure as approved. The granting of these variances are in line with the purpose and intent of the Code and does not confer any special privilege on the Applicant.

(4) Literal interpretation of the provisions of these land development regulations would deprive the applicant of rights commonly enjoyed by other properties in the same zoning district under the terms of these land development regulations and would work unnecessary and undue hardship on the applicant;

A literal interpretation of the provisions of these land development regulations would work an unnecessary and undue hardship on the Applicant. The variance is requested in order to effectuate the redevelopment of the Property while allowing the existing hotel rooms to be retained. Other property owners have sought and been approved for similar variances in order to achieve preservation of historic, contributing structures.

(5) The variance granted is the minimum variance that will make possible the reasonable use of the land, building or structure;

These requests are the minimum necessary in order to allow for the restoration of the historic structure since these are the existing, historic hotel units sizes. Additionally, the proposed sign is modest in sign and is merely being proposed for relocation so that pedestrians can view the sign from the appropriate distance in light of all of the existing restaurant and retail along the ground floor. The rear setback variance request would simply facilitate the continuation of the existing building line to the accessible roof and will provide the required roof protection.

(6) The granting of the variance will be in harmony with the general intent and purpose of these land development regulations and that such variance will not be injurious to the area involved or otherwise detrimental to the public welfare; and

This variances will not be injurious to the area or otherwise detrimental to the public welfare. The variances requested facilitate the preservation, redevelopment and utilization of the Property. These requests are consistent with the purpose and intent of the Code and promote the public welfare in the promotion of the restoration of historic properties.

(7) The granting of this request is consistent with the comprehensive plan and does not reduce the levels of service as set forth in the plan. The planning and zoning director may require applicants to submit documentation to support this requirement prior to the scheduling of a public hearing or any time prior to the board of adjustment voting on the applicant's request.

The variance requested is consistent with the City's comprehensive plan and do not reduce the levels of service as set forth in the plan. It simply retains the existing hotel room sizes and configuration.

<u>Conclusion</u>. The Property's renovation project will further improve the hotel experience for its guests, and will update the structures in a manner appropriate and consistent with the historic district. As always, we look forward to your favorable review.


