Re: Application for Modification of Conditional Use Permit, File No. PB18-0243 ("Application") / Letter of Intent / 14 Farrey Lane, Miami Beach, Florida (the "Property")

Dear Chairperson and Members of the Miami Beach Planning Board:

Our firm represents Chabad Lubavitch of Venetian Causeway and Surrounding Islands, Inc. (the "Applicant"), in connection with certain land use and zoning matters relating to the Property. Please accept this Application and corresponding letter of intent, on behalf of the Applicant, requesting a modification of the existing Conditional Use Permit (the "CUP") issued by the Planning Board on August 24, 2004 (the "Order"); in connection with the construction of a new Chabad House on the Property (the "Project"). For your ease of reference, a copy of the Order is enclosed.

I. The Property History

The Property is located on Belle Isle and is designated Residential Multi-Family, Low Intensity (RM-1) on the City of Miami Beach Official Zoning Map and the City's Future Land Use Map. The RM-1 zoning district allows religious uses through the Conditional Use Permit process. The Belle Isle neighborhood contains a unique and vibrant mixture of neighboring uses all abutting one another; single family residential, multi-family residential, hotel and park.

According to the Survey prepared by Blanco Surveyors, Inc., and dated November 8, 2018, the Property is an irregular shaped lot and is 4,694 +/- square feet¹. The Property was originally constructed in 1941. In 2004, the existing structure was slightly remodeled and converted from a single-family use into a place of worship after obtaining a CUP, as referenced above.

¹ The minimum lot size in the RM-1 district is 5,600 square feet; the Property's lot size is legally non-conforming.

II. The Chabad House

For the past 15 years, Rabbi Mann and his family have serviced the religious needs of the Belle Isle and Venetian Islands community (typically known as a "Chabad House"). By way of background, the Rabbi operates the Chabad House as an orthodox institution, but all forms of Judaism are welcome. At the Chabad House, Rabbi Mann performs religious services, as well as hosts educational and spiritual enrichment sessions catered to the local congregation. The Rabbi's mission at the Chabad House is to provide a relaxed and welcoming environment for local followers to learn more about Judaism and observe the teachings and tenets of Judaism in a safe and intimate space. As a neighborhood Chabad, the congregation is generally localized and is within walking distance (generally less than a one-mile radius)².

III. CUP Modifications

The Applicant requests the following minor modifications to the existing CUP.

A. Condition 3 – Occupancy

The Applicant is requesting a reasonable increase to the maximum occupancy allowed at the Property in order to sensibly accommodate the Chabad's local congregation. Condition 3 of the CUP currently states:

"The maximum occupancy for the Chabad Lubavitch of Venetian Causeway and Surrounding Islands, Inc., shall be as follows unless the Fire Marshall determines that the occupant content for the premises is lower than what is stipulated below:

- Fridays and Saturdays 18 persons
- Other days of the week 15 persons
- Except that there shall be a maximum of 30 persons during the six holidays (six 24-hour periods) a year"

As mentioned above, a Chabad House provides services for local followers of the Jewish Orthodox faith within a walking distance radius. In this capacity, a quorum of ten men (known as a "Minyan") are required to conduct prayer services and other religious obligations at the Chabad House. Typically, Chabad Houses are located in residential spaces where local families come together for Jewish services. Under the existing strict 18-person occupancy limit provided in the current CUP, each man would not be afforded the opportunity to bring his wife and child(ren) to participate in customary public worship and other fundamental religious ceremonies sacred to the orthodox Jewish faith. For example, if ten (10) men participated with their significant other and two (2) children (average American family size), that would equate to at least forty (40) people, which is consistent with the requested occupancy modification demonstrated below. As such, we respectfully request your approval to modify Condition 3 as follows so that families can participate in prayer services and activities at the Chabad House together:

² Orthodox Judaism discourages the use of vehicles on the Sabbath (Friday night and Saturday).

"The maximum occupancy for the Chabad Lubavitch of Venetian Causeway and Surrounding Islands, Inc., shall be as follows unless the Fire Marshall determines that the occupant content for the premises is lower than what is stipulated below:

- Fridays and Saturdays 18 25 persons
- Saturdays 45 persons
- Sundays 30-40 persons
- Other days of the week $-\frac{15}{20}$ persons
- Except that there shall be a maximum of 30 60 persons during the <u>religious six</u> holidays. (six 24 hour periods) a year"

B. Condition 5 – Existing Driveway

The Applicant is requesting the deletion of Condition 5, as the existing driveway will be renovated and increased in size to accommodate two (2) additional parking spaces, for a total of four (4) provided parking spaces at the Property. Condition 5 of the CUP currently states:

"The existing driveway shall be maintained and repaired as may be necessary; and the three parking spaces proposed by the applicant shall not be permitted. The applicant shall pay a fee in lieu of providing the required parking spaces."

Given the significant community input regarding the provision of on-site parking, the Chabad House is designed to accommodate an additional two (2) on-site parking spaces, from what currently exists as undersized spaces, in addition to the availability of on-street parking spaces located on Island Avenue, directly fronting the south side of the Property. Specifically, the existing two (2) car driveway on the Property will be increased from 9.65' x 14.29' to 10' x 18'. Additionally, the increased driveway will be able to accommodate four (4) tandem partially covered parking spaces. As a result, the Applicant respectfully requests the deletion of Condition 5. The Applicant would be amenable to a new condition requiring four (4) on-site spaces in accordance with the proposed plans.

"The existing driveway shall be maintained and repaired as may be necessary; and the three parking spaces proposed by the applicant shall not be permitted. The applicant shall pay a fee in lieu of providing the required parking spaces."

C. Condition 6 - Valet Parking Operator

The Applicant requests the deletion of Condition 6 from the existing CUP, as it currently reads:

"The applicant shall make contractual arrangements with a valet parking operator for the convenience of the persons that may be arriving via private vehicles. The storage of vehicles shall be at a nearby location and not east of Biscayne Bay as originally proposed. Compliance with this condition shall be a pre-requisite to obtaining a Certificate of Use or Occupational License, whichever may apply."

The provision of a valet parking operator for this Property would encourage increased vehicular traffic on Farrey Lane. Additionally, as detailed in Section V below, the unique religious practices of the local Chabad House encourages its congregation to walk to prayer services on Friday, Saturday and religious holidays resulting in the relatively low parking demand for this Property. As such, the costs associated with the operation of a valet operator for a small, neighborhood synagogue would be unreasonably excessive given that the existing off-site parking associated with the Property is generally underutilized during the Chabad House's hours of operation (discussed more fully below). Therefore, the Applicant respectfully requests the deletion of Condition 6 from the CUP as follows:

"The applicant shall make contractual arrangements with a valet parking operator for the convenience of the persons that may be arriving via private vehicles. The storage of vehicles shall be at a nearby location and not east of Biscayne Bay as originally proposed.

D. Condition 10 - Accessibility Ramp

The Applicant also requests the modification of Condition 10, as an accessibility ramp is no longer necessary in light of the proposed Project. As such, Condition 10 of the CUP currently states the following:

"The accessibility ramp proposed on the front of the structure (West elevation) shall not be permitted. The accessibility ramp shall be located on the side or rear of the property with plans to be reviewed and approved by staff."

Condition 10 will no longer apply to the Property as the Project design will comply with all current ADA requirements. As a result, we respectfully request your approval to delete Condition 10 as follows:

"The accessibility ramp proposed on the front of the structure (West elevation) shall not be permitted. The accessibility ramp shall be located on the side or rear of the property with plans to be reviewed and approved by staff."

IV. Religious CUP

Section 118-192(c) of the City's LDRs delineates the standards of review for conditional uses. Specifically, a conditional use for a religious institution shall be approved upon demonstration of the following:

(i) Whether a proposed operations plan has been provided, including hours of operation number of employees, and other operational characteristics pertinent to the application and that such plan will mitigate any adverse impacts to adjoining and nearby properties and neighborhoods.

The existing operations remain essentially unchanged – with a part-time, two-person staff servicing the Chabad House during the following hours of operation. Please

note, the Applicant is not requesting a change to the existing hours of operation contained in the CUP.

Friday: Sundown to 12:00 A.M.Saturday: 10:00 A.M. to 1:00 P.M.

• Sunday: 9:30 A.M. to 12:00 P.M.

• Wednesday: 7:00 P.M. to 10:00 P.M.

• High Holidays: 10:00 A.M. to 1:00 P.M.

The purpose of the Application is to provide a safe comfortable environment for the existing congregation. In support of this Application, an Operational Assessment conducted by Kimley-Horn and Associates, Inc., and dated January 3, 2019, ("Operational Plan") was submitted to the City Transportation Department. As noted throughout, as an orthodox Jewish institution, it is highly encouraged and common practice that the congregation utilize non-motorized means of transportation, such as walking, when traveling to and from the Chabad House on Friday and Saturday prayer services and religious holidays. As a result, the integral tenets associated with the particular religious use for the Property would not warrant the demand consistent with traditional religious parking requirements.

(ii) Whether a plan for the delivery of supplies has been provided, including the hours of operation for delivery trucks to come into and exit from the neighborhood and how such plan will mitigate any adverse impacts to adjoining and nearby properties, and neighborhoods.

Given the low scale and neighborhood friendly operation of the Chabad House, there are no industrial contracts or big box deliveries made to the Property. Similar to the neighboring single-family residences on Farrey Lane and Century Lane, all mail and packages for the Chabad House are delivered by the local postal service or third-party package delivery service (i.e. UPS and Fedex). Generally, there are no more than two (2) deliveries per week made to the Property via the local postal service or third-party package delivery service.

Additionally, garbage disposal for the Property operates on the same schedule as the local residential homes whereby garbage and recycling are scheduled for pick up on Monday and Thursday of each week. As such, there are no adverse impacts to the nearby properties and local neighborhood as the Chabad House operates as any other residential home on Farrey Lane regarding deliveries and garbage disposal.

(iii) Whether the design of the proposed structure is permitted by the regulations in the zoning district in which the property is located, and complies with the regulations of an overlay district, if applicable.

By definition, the Property is an undersized lot and therefore certain setback variances are required to develop the Property, as discussed further below in Section VII. We have worked closely with staff over the past several years to design a sensitive and contextually appropriate space for the local Jewish community. Our architectural team

has studied the recent redevelopment on Farrey Lane and neighboring Century Lane. Specifically, the Project is designed akin to the newly renovated and approved homes where sea level rise and resiliency are reflected in the design. For example, the single-family home located at 7 Farrey Lane was designed and approved utilizing Base Flood plus Freeboard for a height of 39'11". Similarly, the home located at 8 Farrey Lane was approved at a height of 38'6" and three (3) stories. Similar to the new developments on this street, the Chabad House is designed with three (3) stories and up to 40 feet in height for the roof slab, and an additional ten (10) feet in height limited for vertical circulation (e.g., stairwell and elevator equipment).

Notwithstanding the undersized nature of the Property, the Project is largely in compliance with the RM-1 zoning regulations per Section 142-155 of the City's LDRs. The Project will result in 5,750 square feet of FAR, just below the maximum total FAR permitted for the Property. The Property will generally operate in the same manner as it exists today, except that the facilities are more appropriate and modernized for the community's benefit. For example, the current sanctuary space operates as the same venue for all functions which would prevent any delay and inconvenience to the religious services. The new proposal allows for the bifurcation or activities; once the prayer portion of the service is complete, the congregation can transition to an area with tables and chairs for the fellowship component of the service (the "Kiddush"). As demonstrated on the Site Plan, the new design provides adequate space for the religious services and the Kiddush services to be independent of one another.

The new Chabad House also offers improved administrative space where the Rabbi and his wife can meet with congregants in an office or study space to provide various educational and religious enrichment courses such as marital counseling, bar/bat mitzvah lessons and Jewish studies classes. Additionally, the rooftop was designed to create a functional outdoor space where members of the Chabad can perform certain minimal outdoor services. For example, during the holiday of Sukkot there is an obligation to eat in a Sukkah outdoors. We are happy to work with staff to restrict the rooftop area to certain functions and uses throughout the year as it is not intended to be used as a permanent gathering space.

(iv) Whether a proposed parking plan has been provided, including where and how the parking is located, utilized, and managed, that meets the required parking for the use in the zoning district in which the property is located.

Pursuant to Section 130-32(15) of the City's LDRs, synagogues are required to provide one (1) parking space for every six (6) seats or bench seating spaces, unless waived by the Planning Board. The Project has been designed to comfortably accommodate up to 60 congregants during the major religious holidays, requiring approximately ten (10) parking spaces for the Property. As mentioned above, the Project includes a renovated driveway with increased area that will be able to accommodate four (4) tandem parking spaces for the Property. Additionally, due to the low parking demand at this Property because of the limited days/hours of operation, the religious customary practice which discourages the use of any motorized means on the Sabbath and holidays,

in addition to the neighboring City parking facilities along Island Avenue, the Applicant requests a waiver of the remaining required parking spaces for the Property.

(v) Whether an indoor and outdoor congregant/parishioner circulation plan has been provided that facilitates ingress and egress to the site and structure.

The existing outdoor space featured with a garden and seating area located on the South end of the Property will be eliminated with the proposed design for the Project. The Project is design with direct access to the Chabad House from Island Avenue via a secured entry way. The other means of access is located on the North side of the Property, via a second staircase with direct access from the covered parking spaces designed for the Project.

(vi) Whether a security plan for the establishment and supporting parking facility, if any, has been provided that addresses the safety of the institution and its users and minimizes impacts on the neighborhood.

In light of recent current events and attacks against the Jewish community, the existing building is not adequate for the safety of the Rabbi and the Chabad House congregation. The Project has been designed to isolate all religious services and activities within the Chabad House. Although there is no hired security for the Property, the Chabad House will be equipped with state of the art security equipment including electronic door locks requiring a special code to enter the premises as well as security cameras surrounding the Property. Additionally, an off-duty police officer is usually present for special events and religious holidays.³

(vii) Whether a traffic circulation analysis and plan has been provided that details mean of ingress and egress into and out of the neighborhood, addresses the impact of projected traffic on the immediate neighborhood, traffic circulation pattern for the neighborhood, traffic flow through immediate intersections and arterials, and how these impacts are to be mitigated.

The Operational Plan determined that the existing pedestrian features near the Property were sufficient to accommodate the increased pedestrian activity associated with the Project, thereby causing no expected adverse impact to the existing traffic patterns and roadways.

(viii) Whether a noise attenuation plan has been provided that addresses how noise will be controlled in and around the institution, parking structures or areas, and delivery and sanitation areas, to minimize adverse impacts to adjoining and nearby properties.

³ To the extent funding becomes available for on-site security, the Applicant will pursuit that option in order to enhance the security of the Property and local community.

The Project has been designed with a mix of stucco and stone finish cladding on the façade as well as hurricane impact windows which serves to confine any noise produced from the Property. Additionally, all prayer services and activities held at the Chabad House will be held in the interior of the proposed Chabad House (with the exception of the limited use of the roof deck). Also, there will be no augmented or amplified sound devices used at any time on the Property. As a result, any noise produced at the Property will be reduced and virtually eliminated.

(ix) Whether a sanitation plan has been provided that addresses on-site facilities as well as off-premises issues resulting from the operation of the structure.

The Project's sanitation needs will fully comply with the City Code, as a sanitation plan will be provided prior to the submission of a building permit. As mentioned above, the garbage disposal and sanitation for the Property operates in the same manner as the single family residential homes nearby. The Chabad House produces minimal waste throughout the week, and any garbage or waste generally produced by the Chabad House is collected by the City's Waste Management trucks on Monday and Thursday of each week. The Chabad House has hired one general attendant who is charged with cleaning the interior spaces of the Chabad House one day a week (Saturday).

(x) Whether the proximity of the proposed structure to adjacent and nearby residential uses creates adverse impacts and how such impacts are to be mitigated.

The design, scale and massing of the renovation to the Property is appropriate and consistent with several recently approved projects on Belle Isle. Consistent with the proposed CUP modifications and requested parking waiver, the Project will provide a de minimis impact on the surrounding neighborhood as the Project would not increase vehicular traffic or congestion on or around Farrey Lane due to the lack of vehicular use and limited operational hours of the Chabad House.

V. Religious Institution Parking Waiver

Pursuant to Section 130-32(15) the City Land Development Regulations, a religious institution must provide one parking space per six seats or bench seating spaces, which would require a total of ten (10) parking spaces at the Property. Please keep in mind, the proposed sixty (60) seats at the Chabad House are only for major religious holidays. Pursuant to the existing Application, the dominant use of the Property is generally limited to forty-five (45) seats requiring eight (8) parking spaces. In furtherance of the City's goal to decrease dependency of vehicular mobility and to reduce the number of parking structures forecast to be underutilized, Section 130-32(15) allows for a partial or complete waiver of the above-mentioned parking requirements exclusively held for religious institutions less than 8,000 square feet. Accordingly, as a religious institution with a small lot size of 4,694 square feet, the Applicant requests a

waiver to reduce the required number of parking at the Property from ten (10) parking spaces to four (4) parking spaces in accordance with Section 130-32(15).

As an orthodox Jewish institution, it is highly encouraged and common practice that the congregation utilize non-motorized means of transportation, such as walking, when traveling to and from the Chabad House on Friday and Saturday prayer services and religious holidays. As a result, the integral tenets associated with the particular religious use for the Property would not warrant the demand consistent with traditional religious parking requirements. Additionally, the Property is conveniently located adjacent to on-street surface parking along Island Avenue. Similar to larger orthodox synagogues located within the City, nearby on street parking facilities provide adequate parking for small, local religious facilities, such as the Project. Additionally, the traditional hours for religious services are on the weekend when surface parking lots are least active; in other words, the City parking spaces are underutilized during the Chabad House's hours of operation. As such, the construction of any additional private parking spaces or parking structures on the Property would be extremely underutilized as the Chabad House maintains minimal operating hours of 2-4 hours a day, 4 days a week. It is important to note that the Chabad House is not in use during +/- 93% of the year. Given these unique circumstances, the waiver of a portion of the required parking spaces is warranted and would minimize the potential negative impact of increased vehicular traffic through a residential dead-end street, such as Farrey Lane.

VI. Sea Level Rise and Resiliency Review Waiver

Section 133-50(a) provides review criteria for compliance with the City's recently adopted sea level rise and resiliency criteria.

(i) A recycling or salvage plan for partial or total demolition shall be provided.

A recycling plan will be provided as part of the submittal for a partial/total demolition permit to the building department.

(ii) Windows that are proposed to be replaced shall be hurricane proof impact windows.

All renovated and newly constructed windows on the Property will be hurricane proof impact windows.

(iii) Where feasible and appropriate, passive cooling systems, such as operable windows, shall be provided.

Passive cooling systems, such as operable windows, may be installed as appropriate.

(iv) Whether resilient landscaping (salt tolerate, highly water absorbent, native or Florida friendly plants) will be provided.

All new landscaping will consist of Florida friendly plants.

(v) Whether adopted sea level rise projections in the Southeast Florida Regional Climate Action Plan, as may be revised from time-to-time by the Southeast Florida Regional Climate Change compact, including a study of land elevation and elevation of surrounding properties were considered.

Sea Level Rise projections were taken into account, and as a result the proposed Project is designed to Base Flood Elevation (BFE) plus 1' to comply with the LDRs, protect against rising sea levels and encourage flood defense for the Property.

(vi) The ground floor, driveways, and garage ramping for new construction shall be adaptable to the raising of public rights-of-ways and adjacent land.

The proposed driveway into the covered parking area is located at an elevation of 5'3" and 5'5" NGVD. This elevation is consistent with potential future roadway elevations with additional room to raise in the future.

(vii) Where feasible and appropriate, all critical mechanical and electrical systems shall be located above base flood elevation with room to raise.

All critical mechanical and electrical systems will be located on the roof of the structure, including air conditioning units. Please note, there is a proposed ground floor mechanical room located at 5'3" NGVD.

(viii) Existing buildings shall be, where reasonably feasible and appropriate, elevated to the base flood elevation.

The existing building on the Property is located below BFE. The new Chabad House is designed at BFE plus 1' to comply with current LDR requirements at 10' NGVD.

(ix) When habitable space is located below the base flood elevation plus City of Miami Beach Freeboard, wet or dry flood proofing systems will be provided in accordance with Chapter 54 of the City Code.

The proposed redevelopment will not contain any habitable space located below the Base Flood Elevation.

(x) Where feasible and appropriate, water retention systems shall be provided.

The Applicant will explore various water retention systems for the Project.

VII. Design Review Board Variance Requests

In furtherance of the redevelopment of the Property, the Applicant submitted a Design Review Board Application (DRB 18-0346) which included the following variance requests:

- 1. A variance to reduce the minimum lot size requirement of 5,600 square feet within the RM-1 district. The legal lot of record consists of 4,964 square feet.
- 2. Variances to reduce the required front setback of 20 feet in order to accommodate religious use and parking structures. As the lot is irregularly shaped and undersized, certain portions of the building and parking structures are located within the front setback similar to other properties on Farrey Lane.
- 3. A variance to reduce the required 50' side interior setback for religious institutions. The current religious use structure is located less than 5 feet from the side interior Property line. The Applicant proposes to increase the side interior setback up to 9'7".

VIII. Conclusion



CONDITIONAL USE PERMIT

The applicant, Chabad Lubavitch of Venetian Causeway and Surrounding Islands, Inc., filed an application with the Planning Director for a Conditional Use Permit pursuant to Section 118-192 of the City Code. Notice of the request for Conditional Use was given as required by law and mailed out to owners of property within a distance of 375 feet of the exterior limits of the property, upon which the application was made.

The Planning Board of the City of Miami Beach makes the following FINDINGS OF FACT based upon the evidence, information, testimony and materials presented at the public hearing and which are part of the record for this matter:

That the property in question is located in a single-family neighborhood within the RM-1, Low Intensity Multi-Family Residential Zoning District;

That the intended Use or construction will not result in an impact that will exceed the thresholds for the levels of service as set forth in the Comprehensive Plan;

That structures and Uses associated with the request are not consistent with the Land Development Regulations of the City Code, but would be consistent subject to the following conditions;

That the public health, safety, morals, and general welfare will not be adversely affected if the following conditions are in compliance;



That the necessary safeguards will be provided for the protection of surrounding property, persons, and neighborhood values if the following conditions are met.

IT IS THEREFORE ORDERED, based upon the foregoing findings of fact, the evidence, information, testimony and materials presented at the public hearing, which are part of the record for this matter, the staff report and analysis, which is adopted herein, that a Conditional Use Permit as requested and set forth above be GRANTED, subject to the following conditions:

- 1. The Planning Board shall maintain jurisdiction of this Conditional Use Permit. The applicant shall come back to the Board within 90 days of the date of approval of this Conditional Use Permit, or Certificate of Use approval, whichever occurs later, to provide a progress report; mailed notice shall be provided to the residents on Farrey Lane at applicant's expense. The Board reserves the right to modify the Conditional Use approval at the time of a progress report in a non-substantive manner, to impose additional conditions to address possible problems and to determine the timing and need for future progress reports. This Conditional Use is also subject to modification or revocation under City Code Sec. 118-194 (c).
- 2. This Conditional Use Permit is issued to Chabad Lubavitch of Venetian Causeway and Surrounding Islands, Inc., only. Any change of use or ownership shall require review and approval by the Planning Board as a new application.
- 3. The maximum occupancy for the Chabad Lubavitch of Venetian Causeway and Surrounding Islands, Inc., shall be as follows unless the Fire Marshall determines that the occupant content for the premises is lower than what is stipulated below:
 - Fridays and Saturdays 18 persons
 - Other days of the week 15 persons
 - Except that there shall be a maximum of 30 persons during six holidays (six 24-hour periods) a year
- 4. The hours of operation shall be as follows:
 - Friday sundown to midnight.
 - Saturday 10:00 a.m. to 1:00 p.m.
 - Sunday 9:30 a.m. to noon
 - Wednesday 7:00 p.m. to 10:00 p.m.
 - High Holidays 10:00 a.m. to 1:00 p.m.
- 5. The existing driveway shall be maintained and repaired as may be necessary; and the three parking spaces proposed by the applicant shall not be permitted. The applicant shall pay a fee in lieu of providing the required parking spaces.
- 6. The applicant shall make contractual arrangements with a valet parking operator for the convenience of the persons that may be arriving via private vehicles. The storage of vehicles shall be at a nearby location and not east of Biscayne Bay as originally proposed. Compliance with this condition shall be a pre-requisite to obtaining a Certificate of Use or Occupational License, whichever may apply.

- 7. The main entrance to the Chabad Lubavitch of Venetian Causeway and Surrounding Islands shall be through the existing front door on the west elevation of the existing structure.
- 8. No signage shall be permitted.
- 9. A landscape plan shall be submitted to staff for review and approval. The front lawn (south side of property) shall be sodded and the existing landscaping maintained.
- 10. The accessibility ramp proposed on the front of the structure (west elevation) shall not be permitted. The accessibility ramp shall be located on the side or rear of the property with plans to be reviewed and approved by staff.
- 11. Violation of the Miami-Dade County Code Section 21-28 (a/k/a "noise ordinance") shall be deemed a violation of this Conditional Use Permit and subject to the remedies as described in Sec. 118-194 of the City Code.
- 12. The Planning Board shall retain the right to call the Chabad Lubavitch of Venetian Causeway and Surrounding Islands back before them and modify the hours of operation should there be repeat complaints about noise or non-compliance with any of the stated conditions.
- 13. The applicant shall participate in a Transportation Concurrency Management Area Plan (TCMA Plan), as deemed to be necessary, by paying its fair share cost as determined by the Transportation Concurrency section.
- 14. This order is not severable, and if any provision or condition hereof is held void or unconstitutional in a final decision by a court of competent jurisdiction, the order shall be returned to the Board for reconsideration as to whether the order meets the criteria for approval absent the stricken provision or condition, and/or it is appropriate to modify the remaining conditions or impose new conditions.
- 15. The applicant shall satisfy outstanding liens and past due City bills to the satisfaction of the City prior to the issuance of a certificate of use or an occupational license, whichever applies.
- 16. This Conditional Use Permit shall be recorded in the Public Records of Miami-Dade County at the expense of the applicant, prior to the issuance of a Certificate of Use or Occupational License, whichever may be required by City Code.
- 17. The establishment and operation of this Conditional Use shall comply with all the aforementioned conditions of approval; non-compliance shall constitute a violation of the Code of the City of Miami Beach, Florida, and shall be subject to enforcement procedures set forth in Section 114-8 of said Code and such enforcement procedures as are otherwise available. Any failure by the applicant to comply with the conditions of this Order shall also constitute a basis for consideration by the Planning Board for a revocation of this Conditional Use.


