PLANNING BOARD APPROVAL OF A MINOR AMENDMENT TO AN APPROVED CONDITIONAL USE AND SITE PLAN. On 9/3/83 the Planning Board approved the above referred subject pursuant to Sec: 7-1, D-1 of the Zon. Ord. #1891. As required by the ordinance, it is recorded in the office of the City Clerk and the C.E. Department. As noted below the approval incorporated the original conditions approved by the City Commission on 2/16/83 in addition to the following: 1. The existing conditions previously approved by the City and agreed to by the applicant shall be retained as stipulations of this approval. 2. A revised site plan and landscaping plan shall be submitted to the Planning Dept. for review and approval prior to the issuance of a bldg. permit or approval of any revised plans. Also, upon the request of a Certificate of Completion or Certificate of Occupancy, the Planning Dept. will inspect the site to insure improvements, as listed on the landscaping and site plan, are properly in place. 3. All directional signage shall be approved by the Planning Dept. A "Right Turn Only" sign shall be posted on the landscape island nearest the car wash lane and the guard rail located on the rear of the property is to be removed. 4. The flat sign painted on the south wall of the neighboring property to the north shall be removed prior to the issuance of a new or revised building permit.

JUNE 27, 1984 - ON 6/26/84 THE PLANNING BOARD DETERMINED THAT THE REQUEST BY MR. DAVID NEVEL TO AMEND THE APPROVED CONDITIONAL USE WAS A MINOR MODIFICATION AND THUS REQUIRED NO PUBLIC HEARING NO CONSIDERATION BY THE CITY COMMISSION. THE AMENDMENT REMOVED THE CONDITION LIMITING THE SALE OF ACCESSORY ITEMS TO AUTORELATED PRODUCTS AND ALLOWED THE APPLICANT TO OPERATE A "MINI-MART" AS AN ACCESSORY USE TO THE OPERATION OF A FILLING STATION. THE APPROVAL WAS GRANTED WITH THE FOLLOWING STIPULATIONS: 1. THE ORIGINAL CONDITIONS (SEE BELOW) WITH THE EXCEPTION OF THE RESTRICTION ON THE SALE OF ITEMS OTHER THAN THOSE RELATING TO AUTO PRODUCTS, BE RETAINED AS STIPULATIONS OF THIS APPROVAL. 2. THE SALE OF ALL ALCOHOLIC BEVERAGES INCLUDING BEER, WINE AND LIQUOR SHOULD BE PROHIBITED. 3. ARCADE TYPE GAMES SHALL BE PROHIBITED. CONDITIONS: 1. PRIOR TO THE ISSUANCE OF A BLDG. PERMIT, THE PLAN. DEPT. SHALL APPROVE A REVISED PLAN TO INSURE THE RECOMMENDATIONS ADDRESSING LANDSCAPING, SIGNAGE AND CURBING ARE PART OF THE OFFICIAL RECORD. SPECIFIC RECOMMENDATIONS INCLUDE: a. ALL LANDSCAPED AREAS ON PRIVATE PROPERTY ARE TO HAVE A 4"x4" WIDE CURB. b. AN ADDITIONAL LANDSCAPE ISLAND ON THE EAST PROPERTY LINE MAY BE PROVIDED UPON DEPARTMENT REVIEW AND APPROVAL OF THE BLDG. PERMIT PLANS. c. THE EXISTING LANDSCAPED ISLAND (MIDPOINT) IN THE EAST RIGHT-OF-WAY SHALL BE REDESIGNED. d. ALL DIRECTIONAL SIGNAGE SHALL BE INDICATED ON THE REVISED PLAN. e. THE DEPARTMENT SHALL APPROVE THE FINAL LANDSCAPE PLAN AND SITE PLAN. f. GARBAGE FACILITIES SHALL NOT BE VISIBLE FROM ALTON ROAD. g. SALE OF ACCESSORY ITEMS SHALL BE RESTRICTED TO AUTO RELATED PRODUCTS. 3. PUBLIC WORKS: a. CAR WASH TO BE PIPED THROUGH A GAS AND OIL INTERCEPTOR. b. REMOVAL AND REPLACEMENT OF UNUSED PORTIONS OF EXISTING DRIVEWAY WITH HIGH CURB AND SIDEWALK. c. GARBAGE FACILITIES ARE TO BE ENCLOSED NEAR THE ALLEY. d. A SPRINKLER METER SHALL BE PROVIDED. 4. CODE ENFORCEMENT: a. THE CITY COMM. SHALL AMEND SECTION: C-5 GENERAL BUSINESS DISTRICT TO PERMIT FILLING STATIONS AS A CONDITIONAL USE. b. CANOPY FOR THE VACUUM AREA SHALL HAVE A 10 FOOT REAR YARD SETBACK OR THE APPLICANT IS TO OBTAIN A VARIANCE.

BUILDING PERMITS

SUBJECT: CONDITIONAL USE APPROVAL, GASOLINE SERVICE STATION, CAR WASH AND MINI-MART

This is to inform you that on November 24, 1987 the Planning Board approved the applicant's request for Conditional Use approval to operate a gasoline service station, car wash and mini-mart at 1600 Alton Road.

This approval was granted with the following conditions:

1. Landscaping Required - the following materials shall either be used or replacements of equivalent material may be acceptable. The final plan shall be approved by the Planning and Zoning Department prior to the issuance of a building permit or occupational license, whichever is requested first; however an occupational license shall not be issued until the Department approves the installed material.

- the unspecified shrub shown on 16th Street center islands shall be podocarpus;
- Tabebuia Argentina: remove olender and install the material indicated on the plans;
- Hibiscus: change to Ixora Superking;
- Asparagus Fern: change to Pilea;

4. Repaint or replace the light standards.

5. Arcade type games are prohibited.

6. Building Permit Requirements:

- Must obtain D.E.R.M. Class II permit for storm drainage system.
- Provide suitable garbage facility.
- The underground gasoline tanks shall be certified by proper governmental agencies.
- Work exceeding \$100.00 requires a building department permit.

In order to insure that the approval officially becomes part of the City's records, please record the above action on the building card of the subject property.

PLUMBING PERMITS

- Pilea ground cover: change to Lirope;
- the surface rubble in the landscape beds shall be removed and replaced with new planting soil;
- the existing palms along Alton Road shall be removed and replaced with Queen Palms with 8" clear wood. (The Queen Palm is the street tree the City is using for this part of Alton Road); and
- the Planning and Zoning Department shall approve a revised site plan and landscape plan prior to issuance of a building permit and the installed material prior to the issuance of an Occupational License.

2. The existing pole sign at the southwest corner of the property shall be removed if the original plans indicated it was to be replaced; otherwise it may be repaired. Copy on the pole sign shall be approved by the Planning and Zoning Department.

3. Sign copy on the property is limited to language indicating the use of the property for a filling station, car wash or mini-mart; however, there shall be no signage that may be seen by the public which indicates the types of products that are offered for sale in the mini-mart.

As noted below the approval incorporated the original conditions approved by the City Commission on 2/16/83 in addition to the following: 1. The existing conditions previously approved by the City and agreed to by the applicant shall be retained as stipulations of this approval. 2. A revised site plan and landscaping plan shall be submitted to the Planning Dept. for review and approval prior to the issuance of a bldg. permit or approval of any revised plans. Also, upon the request of a Certificate of Completion or Certificate of Occupancy, the Planning Dept. will inspect the site to insure improvements, as listed on the landscaping and site plan, are properly in place. 3. All directional signage shall be approved by the Planning Dept. A "Right Turn Only" sign shall be posted on the landscape island nearest the car wash lane and the guard rail located on the rear of the property is to be removed. 4. The flat sign painted on the south wall of the neighboring property to the north shall be removed prior to the issuance of a new or revised building permit.

JUNE 27, 1984 - ON 6/26/84 THE PLANNING BOARD DETERMINED THAT THE REQUEST BY MR. SHALL APPROVE A REVISED PLAN TO INSURE THE RECOMMENDATIONS ADDRESSING LANDSCAPING, SIGNAGE AND CURBING ARE PART OF THE OFFICIAL RECORD. SPECIFIC RECOMMENDATIONS INCLUDE: a. ALL LANDSCAPED AREAS ON PRIVATE PROPERTY ARE TO HAVE A 4"x4" WIDE CURB. b. AN ADDITIONAL LANDSCAPE ISLAND ON THE EAST PROPERTY LINE MAY BE PROVIDED UPON DEPARTMENT REVIEW AND APPROVAL OF THE BLDG. PERMIT PLANS. c. THE EXISTING LANDSCAPED ISLAND (MIDPOINT) IN THE EAST RIGHT-OF-WAY SHALL BE REDESIGNED. d. ALL DIRECTIONAL SIGNAGE SHALL BE INDICATED ON THE REVISED PLAN. e. THE DEPARTMENT SHALL APPROVE THE FINAL LANDSCAPE PLAN AND SITE PLAN. f. GARBAGE FACILITIES SHALL NOT BE VISIBLE FROM ALTON ROAD. g. SALE OF ACCESSORY ITEMS SHALL BE RESTRICTED TO AUTO RELATED PRODUCTS. 3. PUBLIC WORKS: a. CAR WASH TO BE PIPED THROUGH A GAS AND OIL INTERCEPTOR. b. REMOVAL AND REPLACEMENT OF UNUSED PORTIONS OF EXISTING DRIVEWAY WITH HIGH CURB AND SIDEWALK. c. GARBAGE FACILITIES ARE TO BE ENCLOSED NEAR THE ALLEY. d. A SPRINKLER METER SHALL BE PROVIDED. 4. CODE ENFORCEMENT: a. THE CITY COMM. SHALL AMEND SECTION: C-5 GENERAL BUSINESS DISTRICT TO PERMIT FILLING STATIONS AS A CONDITIONAL USE. b. CANOPY FOR THE VACUUM AREA SHALL HAVE A 10 FOOT REAR YARD SETBACK OR THE APPLICANT IS TO OBTAIN A VARIANCE.

- Arcade type games are prohibited.
- Building Permit Requirements:
 - Must obtain D.E.R.M. Class II permit for storm drainage system.
 - Provide suitable garbage facility.
 - The underground gasoline tanks shall be certified by proper governmental agencies.
 - Work exceeding \$100.00 requires a building department permit.
