A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, ACCEPTING THE RECOMMENDATION OF THE FINANCE AND CITYWIDE PROJECTS COMMITTEE AT ITS SEPTEMBER 20, 2019 MEETING, AND APPROVING THE CITY'S SPONSORSHIP OF THE 2019 CIRCUIT FESTIVAL MIAMI EVENT, ORGANIZED BY URGE MIAMI LLC (THE "EVENT"), TO BE HELD ON THE LUMMUS PARK BEACHFRONT, EAST OF THE DUNES, BETWEEN 12TH STREET AND 13TH STREET, ON SUNDAY, DECEMBER 1 2019, WITH CITY'S SPONSORSHIP CONTRIBUTION CONSISTING OF SPECIAL EVENT PERMIT FEE WAIVERS IN SUPPORT OF THE EVENT, IN AN AMOUNT NOT TO EXCEED \$13,396.10.

WHEREAS, in furtherance of the City's commitment to diversity, the City has a long history of supporting LGBTQ events in the City of Miami Beach; and

WHEREAS, the 2019 Circuit Festival Miami event will be held on Sunday, December 1, 2019, on the Lummus Park beachfront, east of the dunes, between 12th Street and 13th Street (the "Event"), with load-in commencing on Thursday, November 28, 2019 and load-out by Monday, December 2, 2019; and

WHEREAS, on September 11, 2019, the Mayor and City Commission referred an agenda item to the Finance and Citywide Projects Committee ("FCWPC"), sponsored by Commissioner Michael Gongora, to consider the waiver of special event permit fees for the Event; and

WHEREAS, on September 20, 2019, the FCWPC recommended that the City of Miami Beach waive City special event permit fees for the Event; and

WHEREAS, the fee waivers for the Event include the \$250 application fee, the \$500 permit fee, \$1,800.00 for vehicle beach access passes, \$7,730.00 in square footage fees, \$1,737.00 in user fees, and \$838.00 in Police administrative fees, for a total not to exceed amount of \$13,396.10.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby accept the recommendation of the Finance and Citywide Projects Committee at its September 20, 2019 meeting, and approve the City's sponsorship of the 2019 Circuit Festival Miami event, organized by Urge Miami LLC, to be held on the Lummus Park beachfront, east of the dunes, between 12th Street and 13th Street, on Sunday, December 1, 2019, with the City's sponsorship contribution consisting of the waiver of City special event permit fees, in an amount not to exceed \$13,396.10.
