A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, APPROVING AND AUTHORIZING THE CITY MANAGER TO ACCEPT A DONATION OF OUTDOOR GYM EQUIPMENT FROM TIGER FITNESS, WHICH WILL BE LOCATED IN THE 6<sup>TH</sup> STREET FITNESS AREA IN LUMMUS PARK, FOR THE USE AND BENEFIT OF THE PUBLIC; AND FURTHER AUTHORIZING THE CITY MANAGER TO COMPLETE INSTALLATION OF THE EQUIPMENT PRIOR TO THE SUPER BOWL LIV WEEKEND IN 2020.

**WHEREAS**, the City of Miami Beach has been offered a donation of certain outdoor gym equipment by Tiger Fitness, known as "StreetBarbell USA" machines, featuring a combined exerciser, ab/back trainer, shoulder press, bench press, squat machine, combo-lift, seated dips, multi-bar, pulldown and a rowing machine; and

**WHEREAS**, the donated gym equipment will be installed in the 6<sup>th</sup> Street fitness area in Lummus Park, subject to any and all required City approvals; and

**WHEREAS**, timeliness is a factor, as the City wishes to have the equipment installed prior to the Super Bowl LIV weekend in 2020; and

**WHEREAS**, Tiger Fitness will coordinate the installation of the outdoor gym equipment with City Staff; and

**WHEREAS**, the City will be responsible for any required fill, landscaping, and permitting that may be required for the installation of the donated outdoor gym equipment; and

**WHEREAS**, the state-of-the-art outdoor gym equipment to be donated by Tiger Fitness is valued at \$73,000.00, and will provide a high-quality fitness amenity to be used and enjoyed by the public.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby approve and authorize the City Manager to accept a donation of outdoor gym equipment by Tiger Fitness, which will be located in the 6<sup>th</sup> Street fitness area in Lummus Park, for the use and benefit of the public; and further authorize the City Manager to complete installation prior to Super Bowl LIV weekend in 2020.
