At the upcoming December 11, 2019 Commission meeting, the Miami Beach City Commission is proposing an Ordinance that requires that starting with the November 2021 General Election, Early voting for a Run-Off Election in the City of Miami Beach shall occur on the <u>Friday</u>, Saturday, and Sunday immediately preceding any Run-Off Election.

This would increase the number of early voting days for a Run-Off Election from 2 to 3 days, and will coincide with the Early Voting Run-Off schedule for the cities of Hialeah and Miami Beach.

In an abundance of caution, I wanted to obtain your approval of such a change, prior to submitting it for consideration by the City Commission.
