## Why audit the Miami Beach Bicycle Master Plan?

Two wheels should be more than enough.

Our bike network has been fragmented and unsafe for years – and as more people choose to get to work, access services, and get around on two wheels – we need to build safer infrastructure to connect communities and places.

**In 2015 – Miami Beach adopted a [comprehensive bike master plan](#).  
5 years later, almost nothing has been added to the network.**

**Category 1<sup>1</sup>** in the master plan consisted of filling in the gaps in the existing network with a series of critical projects to improve connectivity by 2020.

## A Note on Shared Road Markings



Approximately 2 miles of shared road markings, or sharrow, have been completed since 2015, with 5.8 miles missing. But sharrow aren't bike lanes – [studies have shown that sharrow are ineffective or even dangerous](#). We do not count sharrow in any of our analysis.

## Additional Goals

This map leaves key gaps in North Beach and Middle Beach where sharrow need to be converted to bike lanes.

The Bicycle and Pedestrian Master Plan also includes additional goals on a 20 year timeline, with little to no progress, and needs to be expedited.

**Category 2<sup>3</sup>** focuses on the improvement of existing infrastructure, and includes 23 miles of protected bike lanes in major corridors and separate, protected infrastructure for cyclists on the causeways. 0.4% of bike lanes have been completed.

**Category 3<sup>4</sup>** is an aspirational long term network consisting of an additional 17 miles of protected biking infrastructure throughout Miami Beach and into the mainland. 0.2% of bike lanes have been completed.

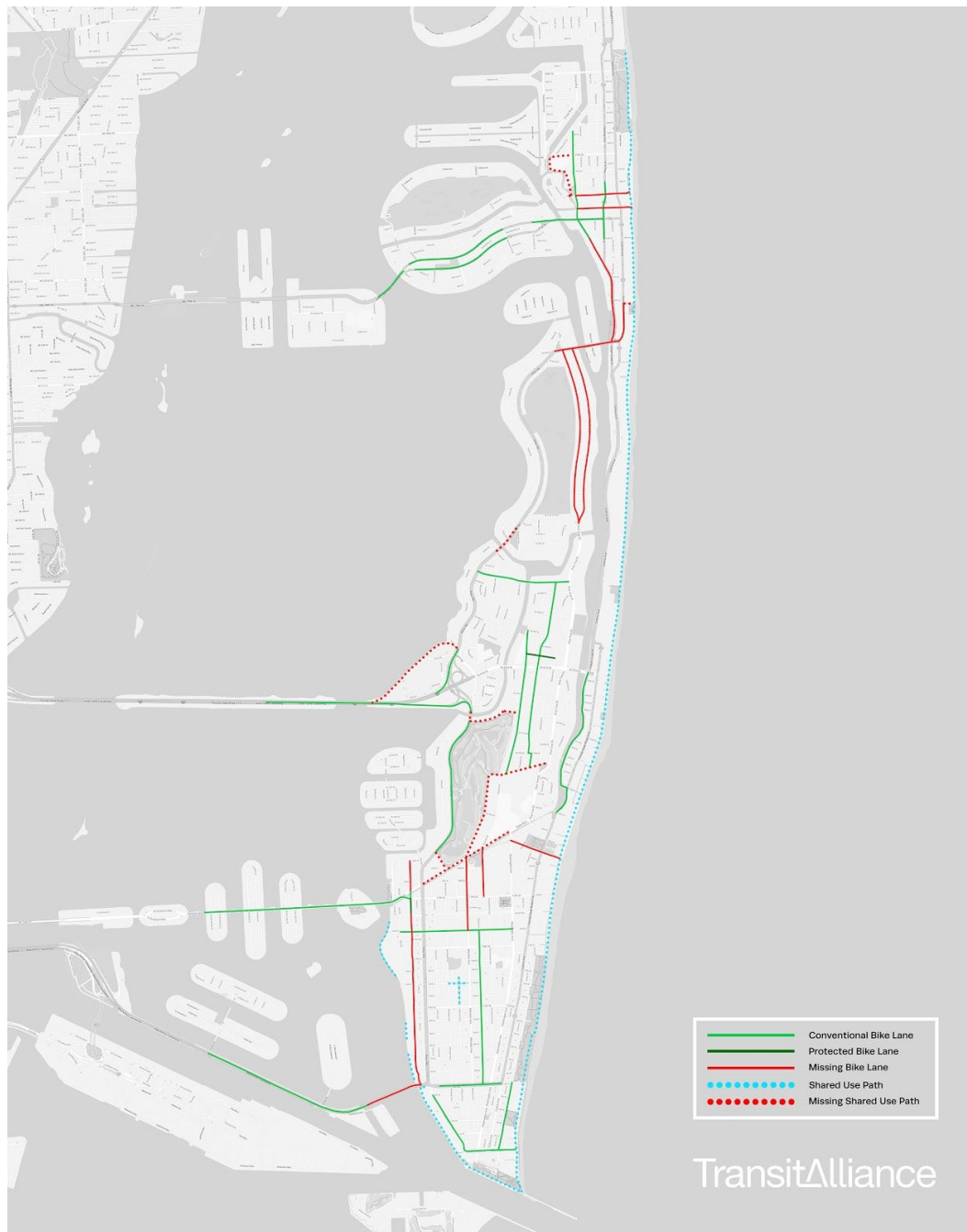

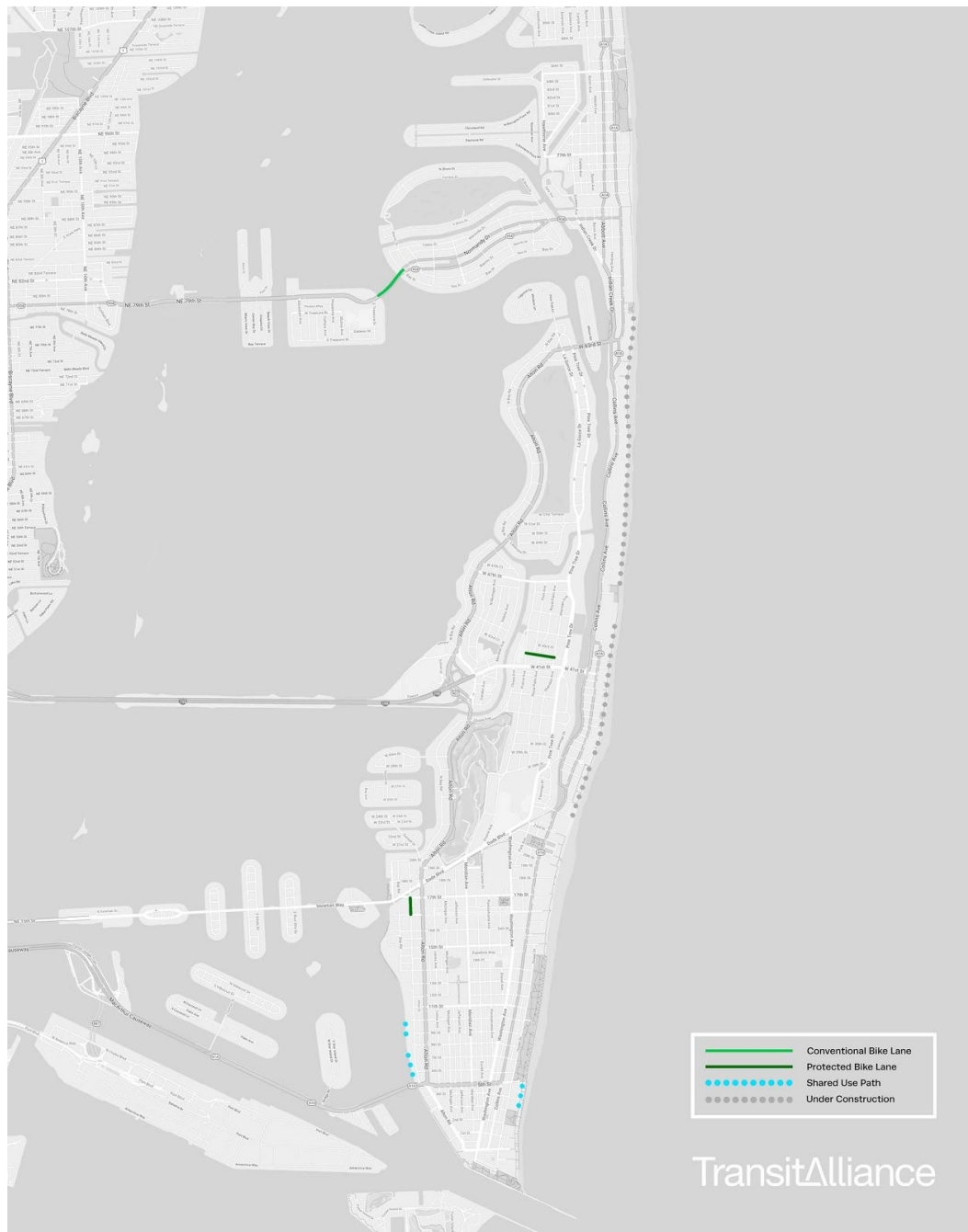
