RESOLUTION 19-20-14

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE LINCOLN ROAD BUSINESS IMPROVEMENT DISTRICT, INC., URGING MIAMIDADE COUNTY MAYOR CARLOS A. GIMENEZ TO MOVE THE EXISTING COUNTYWIDE CURFEW FROM 11:00 PM UNTIL AT LEAST 12:00 AM.

WHEREAS, on July, 2, 2020, in response to the Coronavirus Disease 2019 (COVID-19), Miami-Dade County Mayor Carlos A. Gimenez issued an Emergency Order imposing a curfew for all incorporated and unincorporated parts of Miami-Dade County, effective from 10:00 PM each night to 6:00 AM the following morning; and

WHEREAS, on the same day Mayor Gimenez announced the county curfew health officials reported more than 10,000 new COVID cases statewide and Miami-Dade County reported a positivity rate over twenty percent (20%); and

WHEREAS, as a result of the collective actions of government and civic leaders and the efforts of our community, the number of new COVID cases reported for the City of Miami Beach, Miami-Dade County, and the State of Florida have declined significantly since July 2; and

WHEREAS, the county curfew has had a particularly devastating impact on restaurant owners and workers because many restaurants, especially in the City of Miami Beach, generate a significant portion of their revenue after 10:00 PM; and

WHEREAS, many restaurant owners and workers in our community are struggling to make ends meet; and

WHEREAS, on September 11, 2020, Mayor Gimenez executed an amendment to the Emergency Order, setting the countywide curfew to begin at 11:00 PM (instead of 10:00 PM) effective September 14, 2020; and

WHEREAS, on September 16, 2020, the Miami Beach Mayor and City Commission will consider a resolution urging Mayor Gimenez to set the countywide curfew to begin at or after 12:00 AM (instead of 11:00 PM); and

WHEREAS, the Board of Directors of the Lincoln Road Business Improvement District believes the adjustment of the countywide curfew to begin at or after 12:00 AM (instead of 11:00 PM) will offer restaurant owners and workers a critical opportunity to protect their livelihoods, while providing a valuable service our community and acting responsibly in order to prevent the spread of COVID-19.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE LINCOLN ROAD BUSINESS IMPROVEMENT DISTRICT, INC.:

<u>Section 1</u>. The Board of Directors of the LRBID hereby respectfully urges Mayor Gimenez to set the countywide curfew to begin at or after 12:00 AM (instead of 11:00 PM).

<u>Section 2.</u> The Board of Directors of the LRBID hereby directs the Executive Director of the LRBID to transmit a copy of this resolution to Mayor Gimenez, as well as the City Commission and the City Manager of the City of Miami Beach.
