



## **NoMi DELIVERS**

The **NoMi Delivers** program is available for eligible existing small businesses classified under hospitality industry: restaurants, breweries, cafes, etc. affected by Miami-Dade County's No Dine-In Order.

This program will be available during the COVID-19 pandemic or until funds are depleted.

### **PARTICIPATION**

NMCRA will:

1. Reimburse participating restaurants a portion of their fees in the following manner:
  - ✚ No more than 30% of total fees incurred from delivery service entities up to \$5,000 a month total for all delivery services.
2. Offer free delivery to North Miami residents and employees working within the NMCRA boundaries, using assigned promo code.

### **REQUIREMENTS**

1. Must be within the NMCRA geographic boundary.
2. Must apply and be accepted into the NoMi Delivers program.
3. Past NMCRA Commercial grantees are eligible to apply.
4. No fees prior to the program inception are reimbursable.
5. Applicable City of North Miami/county/state licenses must be up to date.
6. No more than one (1) other location, not part of a national chain or franchise.
7. No nightclubs, bars, mobile food trucks, restaurants within hotels, no home based businesses.
8. No more than one application submitted for the same business, business owner, family member, or partners.
