CITY HALL (CH) PARKING PERMIT

City Hall (CH) parking permit holders are only allowed access to the City Hall Garage (G7). Employee City ID is required to enter and exit the garage. City Employees are required to park on the 3rd and upper levels of the City Hall Garage.

CITYWIDE (CW) PARKING PERMIT

A citywide (CW) parking permit is honored at metered parking spaces and at restricted residential zones. CW parking permit holders are also allowed access to the City Hall Garage using their City ID. A CW parking permit **IS NOT** honored in prohibited areas.

IMPORTANT NOTE: Your vehicle license plate serves as your "parking permit". In order to avoid any unnecessary enforcement actions, it is important that our records reflect the most current and accurate information regarding your vehicle license plate. Inaccurate and/or outdated vehicle information may lead to the issuance of parking citation(s) and/or the towing of your vehicle.

G PARKING PERMIT

A G parking permit is honored at metered parking spaces and at restricted residential zones. G Parking permit holders are also allowed access to ALL City garages using their City ID.
