My name is Eliana Martinez and I am writing to ask for your support to protect the MiMo clock tower on 71st Street and save it from demolition. Please vote 'no' on the appeal and uphold the DRB's decision. The most recent discussions regarding development in North Beach have consistently supported preserving the iconic clock tower in Town Center. Residents and experts alike want this iconic structure saved.

In fact, the award-winning North Beach Master Plan, created by Dover Kohl around the widespread consensus of the North Beach community stakeholders and adopted by unanimous consent of the Miami Beach Commission, singles out two iconic landmarks that should be preserved and highlighted as place-making iconic architecture in North Beach.
