Our firm represents Bancroft Oceans Five Holdings, LLC, the owner of the Bancroft Hotel and Ocean Steps property at 1501 Collins Avenue. Our application seeking Conditional Use approval for an exciting redevelopment of the property is set for review by the Board on March 23. The redevelopment plan calls for the replacement of a large nightclub/performance space with new Class A+ office space and new restaurant concepts. We believe that the redevelopment will be part of the City's planned reinvention of this area of the City, anchoring the north end of Ocean Drive with a truly transformative use.
