Saturday & Sunday Brunch 12 noon to 6 PM.

## Security

Security: alarm system on off hours

Security: security company hired on busy days, depending, always on

weekend nights and brunch.

Security: all deliveries checked by security guard, all employees checked in and out by security guard hired by hotel, entrance in back of building on  $20^{th}$  street.

Indoor & Outdoor Crowd Control Plan
Indoor/Outdoor Crowd Control Plan: Existing
Outside door person with reservation list, standing by entrance.

- Assisted by security guard, as described below
- Controls crowd
- Chooses who may enter
- Checks identification for young people
- Helps with walk-ins with no reservations when space exists inside

- Obtains minute-by-minute updates from inside managers about occupancy numbers, to prevent overcrowding and to comply with occupancy limits.
- Schedule:
  - Thursday: On call, following reservations levels, from 9 PM to closing.
  - Friday & Saturday: 9 PM to closingSunday: Brunch: 12 Noon to closing

Security Guard, between 1 and 2, depending on specific needs of the time

- Assists outside door person, guaranteeing safety of outside door person and patrons.
- Keeps sidewalk free for people to pass
- Maintains general order
- Moves inside as outdoor crowd things to show security presence and assist as needed

Maitre d's, Managers & Hostesses Inside

- On the floor
- At reception desk by entrance
- Welcome and assist guests

# Age Control

- Minors may enter only with parents. Parents are warned that minors cannot sit at the bar and cannot be served.
- Patrons who appear young: ID is checked by outside doorman.
   They may again be carded at the table by managers and/or waiters. Further, front-of-house employees have mandatorily been trained through a program called Hospitality Compliance, and handle under age patrons pursuant to that program.

#### Trash

Shared with hotel, trash room in back of building. Daily pick up.

#### Deliveries

From the entrance on 20<sup>th</sup> street, through security check point.
