### 1. AFFORDABLE HOUSING ADVISORY COMMITTEE

VACANCIES (3):

- One citizen actively engaged in the residential home building industry in connection with affordable housing. (Category # 1)
- One citizen actively engaged in the banking or mortgage banking industry in connection with affordable housing. (Category # 2)
- One citizen who is a representative of those areas of labor actively engaged in home building in connection with affordable housing. (Category # 3)

#### 2. ANIMAL WELFARE COMMITTEE

VACANCY (1):

 An individual who shall be recommended by the Miami Beach Animal Advocates Inc. and ratified by the City Commission.

#### 3. DESIGN REVIEW BOARD

VACANCY (1):

One landscape architect registered in the State of Florida. (Category # 3)

### 4. HEALTH ADVISORY COMMITTEE

VACANCY (1):

• Ex-Officio, Miami-Dade County Health Department.

### 5. HEALTH FACILITIES AUTHORITY BOARD

VACANCY (1):

Attorney.

#### 6. HUMAN RIGHTS COMMITTEE

VACANCY (1):

• At-Large. The members of the Committee shall reflect, as nearly as possible, the diversity of individuals protected under the City's Human Rights Ordinance.

### 7. **NEXT GENERATION COUNCIL** (1-year term)

**Note:** Members must be eighteen (18) years through thirty-six (36) years of age at the time of appointment.

VACANCIES (2):

- One member must be a business owner in the City. (Category A)
- One member must be licensed and actively practicing in the field or architecture or engineering. (Category C)

### 8. PARKS AND RECREATIONAL FACILITY

VACANCY (1):

• One member who has demonstrated a high degree of interest, participation and/or expertise in the sport of golf.

#### 9. PERSONNEL BOARD

VACANCY (1):

• One citizen of Miami Beach not in the employment of the City; NOT having one of the following professions: Psychotherapist; Executive Director/Non-Profit Organization; Translator; International Sales Manager/Consultant; or Concert Producer/Impresario.

# 10. SENIORS AFFAIRS COMMITTEE

VACANCIES (2):

- A resident of the Blackstone Apartments who shall be recommended by the residents of the Blackstone Apartments and ratified by the City Commission. (Category # 4)
- A resident of the Council Towers North who shall be recommended by the residents of Council Towers North and ratified by the City Commission. (Category # 7)
