<u>Agreement No.</u> RFP 2014-015-LR	<u>Title</u> Psychological Services for Public Safety Personnel	
<u>Contractor</u> Law Enforcement Psychological and Counseling Associates, Inc.	<u>Current Term</u> 2/3/2021– 8/3/2021	<u>Renewal Term</u> Month-To-Month
<u>Brief Scope:</u> The purpose of this Agreement is to provide pre-employment psychological screening to certain public safety positions as required, as well as counseling services as needed.		
<u>Justification:</u> The Contractor has provided background investigation services for numerous Police and Fire Department applicants during the current term of the Agreement. The services provided by the Contractor are mandatory before the Police and Fire Departments can fill certain open positions. In November 2020, the City issued Request for Proposals (RFP) 2021-020-KB for Pre-Employment Testing & Psychological Services for Sworn & Public Safety Personnel in anticipation of the current agreement expiring on August 3, 2021. The City received a sole proposal to the RFQ, which could not be accepted because the proposed costs exceeded current costs by approximately 300%. Therefore, the sole proposal was rejected. Accordingly, the City subsequently issued RFP 2021-027-AY, with proposals now due on July 15, 2021. A month-to-month of the current agreement is necessary to all staff to properly evaluate any proposal(s) received. Staff anticipates completing this process and presenting an award recommendation for the RFP to the Mayor and City Commission at its scheduled September Commission meeting. Therefore, as the services are still needed, it is in the City's best interest to extend the current agreements on a month-to-month basis until a replacement Agreement is executed.

<u>Contractor</u> Structured Cabling Solutions, Inc. (Primary Vendor)	<u>Current Term</u> 2/01/2021 – 8/1/2021	<u>Renewal Term</u> Month-To-Month
ASE Telecom & Data (Secondary Vendor)	1/27/2021 – 7/27/2021	Month-To-Month
<u>Brief Scope:</u> The purpose of this Agreement is to provide telecommunications wiring services at all the City's facilities.		
<u>Justification:</u> During the current term of the Agreement, Structured Cabling Solutions, Inc. (primary vendor) has provided wiring services for the City's data, cable television video, and voice network for various projects. These services are required by several departments to complete numerous wiring projects on an as needed basis. On March 15, 2021, the City issued Invitation to Bid (ITB) No. 2021-050-JC for structured cabling services with an opening date of April 22, 2021 and in anticipation of the current agreements expiring on August 1, 2021 (primary) and July 27, 2021 (secondary). On June 23, 2021, the City Commission approved the award of contracts to the following firms: Structured Cabling Solutions, Inc., as the primary vendor; 4 Best Business Corp., as the secondary vendor; and Unitec, Inc., as the tertiary vendor. The contracts pursuant to the recently awarded ITB 2020-050-JC are currently in the process of being executed. A month-to-month extension is necessary to allow for the completion of the replacement contracts while providing an authority for the departments to continue to meet their operational needs. Staff anticipates that the replacement contract will be executed within the upcoming month. Therefore, as the services are still needed, it is in the City's best interest to extend the current agreements on a month-to-month basis until a replacement Agreement is executed.
