

**ORDINANCE NO. \_\_\_\_\_**

**AN ORDINANCE OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, AMENDING THE CODE OF THE CITY OF MIAMI BEACH, FLORIDA, BY AMENDING APPENDIX A, "FEE SCHEDULE," TO REVISE FEES CHARGED FOR SIDEWALK CAFE PERMITS; PROVIDING FOR REPEALER, SEVERABILITY, CODIFICATION, AND AN EFFECTIVE DATE.**

**WHEREAS**, the City of Miami Beach has the authority to enact laws which promote the public health, safety and general welfare of its citizens; and

**WHEREAS**, Section 83-383 of the City Code references per-square-foot fees in order to obtain or renew a sidewalk cafe permit; and

**WHEREAS**, the City's current fee per square foot to obtain a sidewalk cafe permit is based upon a cost-recovery model designed to recoup for the City its expenses incurred administering the sidewalk cafe program; and

**WHEREAS**, the City has determined that transferring to a new revenue-generation model for sidewalk cafe permit fees is in the best interests of the City; and

**WHEREAS**, the City has determined that an adjustment of the per square foot annual fee to obtain a sidewalk cafe permit and of the base application fee for a sidewalk cafe should be enacted to reflect an amount that advances the City's revenue-generation interests while taking into account the current rate to rent space on the City's main sidewalk cafe corridors.

**NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA:**

**SECTION 1.**

That Appendix A, entitled "Fee Schedule," is hereby amended as provided in "Exhibit A" to this Ordinance.

**SECTION 2. REPEALER.**

All ordinances or parts of ordinances and all section and parts of sections in conflict herewith be and the same are hereby repealed.

**SECTION 3. CODIFICATION.**

It is the intention of the City Commission, and it is hereby ordained that the provisions of this ordinance shall become and be made part of the Code of the City of Miami Beach as amended; that the sections of this ordinance may be renumbered or relettered to accomplish such intention; and that the word "ordinance" may be changed to "section" or other appropriate word.

**SECTION 4. SEVERABILITY.**

If any section, subsection, clause or provision of this Ordinance is held invalid, the remainder shall not be affected by such invalidity.

**SECTION 5. EFFECTIVE DATE.**
