CORRECTIONS		<p>Item R5 D, page 3 of the Ordinance, subsection (2) d., replace with the following:</p> <p>Is in violation of subsection 46-152(b) and the noise is emanating from any vehicle, including bicycles, electric bicycles and motorized bicycles, or from any vessel, except that the joint and several liability provision set forth within section 46-153 shall not apply to privately owned vehicles and vessels, which are neither rented or leased nor available for rent or lease to the general public. only apply to rental business operators that rent vehicles or vessels to the general public.</p> <p>Item R9 C, page 3 of the memorandum, paragraph 5, the reference to the "attached" memorandum was made in error, as there is no attachment.</p>
