A RESOLUTION OF THE CHAIRPERSON AND MEMBERS OF THE MIAMI BEACH REDEVELOPMENT AGENCY (RDA), SETTING THE DATES FOR THE YEAR 2022 RDA MEETINGS.

WHEREAS, pursuant to its By-Laws, the Miami Beach Redevelopment Agency (RDA) shall meet at such times as prescribed by resolution; and

WHEREAS, the Mayor and City Commission also sit as the RDA, and schedule the Redevelopment Agency meetings to coincide with the City Commission meetings; and

WHEREAS, the Administration suggests that when scheduling the 2022 RDA meeting dates, the RDA Members accomplish four goals: 1) schedule one RDA meeting a month; 2) schedule the RDA meetings on the same day as the City Commission meetings; 3) schedule RDA Meetings on Wednesdays; and 4) not schedule RDA meetings during the month of August, while the RDA is in recess; and

NOW, THEREFORE, BE IT DULY RESOLVED BY THE CHAIRPERSON AND MEMBERS OF THE MIAMI BEACH REDEVELOPMENT AGENCY, that the Mayor and City Commission hereby approve the proposed 2022 RDA Meeting dates set forth in Exhibit "A" hereto.
