9. Deauville Hotel – update TIME CERTAIN 9:00 A.M.

Motion 1: Urge the City to hire an independent structural engineer with historic preservation expertise or in lieu of that hire a historic preservation consultant to assist a structural engineer in evaluating the feasibility of retaining, restoring, and shoring the building in whole or in part.

Additionally, the Board recommends that funding be allocated for that purpose.
