Dear Mr. Chairman Kareem Brantley and dear Members of the Planning Board:

I am following up to the application by the Sagamore PB21-0457 – 1671 Collins Avenue and the yesterday's meeting. You agreed to the entertainment application with some – from my point of view – minor conditions after longer discussions with Mr. Gonzales, the lawyer for the Sagamore Hotel. One of the discussions points related to the videos dated December 1, 2021 and New Year's Eve which were forwarded to you. I got these videos from Richard Enfanto who is a co-owner at the Decoplage Condominium, 100 Lincoln Road where I am also owning two units. Mr. Gonzales denied flatly that these videos' soundtrack came from the Sagamore Hotel. It seems to be obvious that his denial was wrong. Please find attached a statement by Richard Enfanto which explains specifically that the soundtrack of the December 1 video could only come from a large special entertainment event at the Sagamore Hotel. I do not understand how Mr. Gonzales could deny this fact. Based on

his wrong denial I am kindly asking you to re-open the case and either to deny the application of the Sagamore Hotel or to condition that the hours of the entertainment license is every day until midnight.
