"I respectfully request the Board not to modify the Conditional Use Permit currently in place for Goodtime.

At a recent Historic Preservation Board meeting Goodtime admitted they have been able to avoid citations and violations recently because they are keeping the volume at the pool deck to an ambient level. The Board should ensure Goodtime continues to abide by the condition they accepted in 2016.

The Board should not comply with Goodtime's posted request for a modification allowing them to select the allowable sound level at points west of Washington Avenue.

If any modification to the CUP is accepted by the Board it should follow Staff's recommendation:"  
The sound from the Applicant's sound system shall not be audible within any area to the west of

Washington Avenue at any time.”
