A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, ADOPTING THE CERTIFICATE OF THE RESULTS OF THE NOVEMBER 8, 2022 MIAMI BEACH SPECIAL ELECTION TO FILL THE VACANCY IN CITY COMMISSION GROUP II.

WHEREAS, pursuant to law, the Miami-Dade County Canvassing Board was appointed and authorized to canvass the City of Miami Beach's November 8, 2022 Special Election to Fill the Vacancy in City Commission Group II, which was duly conducted by the Elections Department of Miami-Dade County, Florida; and

WHEREAS, the results of the November 8, 2022 Special Election to Fill the Vacancy in City Commission Group II have been certified by the Miami-Dade County Canvassing Board; and

WHEREAS, the candidates for City Commissioner in Groups II have received the number of votes cast as reflected more specifically within the Certificate of Election Results attached hereto as Composite Exhibit "A" and incorporated herein;

WHEREAS, with regard to City Commission Group II, no candidate received a majority of the votes cast as required by Sec. 2.01 of the City Charter; therefore, a Run-Off Election will be held on December 6, 2022, as authorized by City Resolution 2022-32260 and City Ordinance 2022-4507;

WHEREAS, the Run-Off Election results for City Commissioner Group II will be adopted by the Miami Beach City Commission on December 12, 2022, followed by the newly-elected official's swearing-in.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Miami-Dade County Canvassing Board having canvassed the returns of the November 8, 2022 Special Election to Fill the Vacancy in City Commission Group II of the City of Miami Beach, the Mayor and City Commission hereby adopt the attached Certificate of the results of said Special Election and it is hereby ordered that the Certificate of Election Results and this Resolution be recorded in the minutes of the November 21, 2022 City Commission meeting as a permanent record of the results of the November 8, 2022 Special Election to Fill the Vacancy in City Commission Group II; and be it further resolved that by the adoption of this Resolution, the Canvassing Board has discharged its duties for said Special Election.
