ADDENDUM TO ABROGATION AND RELEASE AGREEMENT

This Addendum hereby becomes part of the Abrogation and Release Agreement ("Agreement") between Miami-Dade County, Florida ("Grantee"), and the United States of America, acting by and through the Administrator of General Services ("Grantor"), approved on October 18, 2022, by the Miami-Dade Board of County Commissioners through Resolution 994-22.

Amendment(s). WHEREAS it was the intention of the parties that the purchase price of \$4,590,000 paid by the Grantee was intended to be consideration not only for the release of the use restriction and right of reversion described in the Agreement, but also for the release of the use restriction and right of reversion contained in an easement encumbering the Property;

GRANTOR and GRANTEE agree that the Agreement shall be amended to add the following terms:

GRANTOR, by execution of this Agreement, agrees to release GRANTEE, its successors and assigns, from the use restrictive covenant and right of reversion contained in that certain Quitclaim Easement Deed conveyed to Miami-Dade County on October 5th, 1989, and recorded in Official Records Book 14605, Page 3565 (the "Easement"), which is attached hereto as Exhibit "B" and made a part hereof, and remove the use restrictions affecting the Property set forth in the Easement. GRANTOR, by execution of this agreement, removes, releases and extinguishes its rights provided in the original Easement to retake possession of the Property and exercise its rights of reversion.

All other terms and conditions of the Agreement shall remain the same. This Addendum shall go into effect on the date this Addendum is signed by the Parties.
