Just to let you know, the Conditional Use Permit (CUP) issued in 2019 was strict. Then two year later the venue asked for and was granted a modification to the CUP in 2021 that allowed rooftop entertainment.

CUP issued 2019

Indoors operate Sun to Wed until midnight operate Thurs to Sat until 2AM

Outdoor
all operation must cease at midnight
music and entertainment **not** permitted outdoors

Michele,

I am so disheartened to hear that the loud music at The Eatery continues. I will help you navigate the system.

The rooftop eatery appeared at Planning Board April 26, 2033 and May 22, 2022. At that time the board was made aware of noise complaints reported by Code Compliance. The venue's original order requires a password protected volume control that only the manager can control, but obviously that rule was not being complied with. Therefore, I voted to take away permission for rooftop entertainment, but I was out voted. Afterwards, I called the landlord who told me they were trying to evict the rooftop tenant. The court date for eviction was September 2022. I do not know the outcome of that judgement. Landlord would not tell me why they were evicting, but mentioned that the tenant was paying their rent on time.

Yes, it is certainly a burden to call and meet in person Code Compliance at 1AM. Unfortunately that is how our system is set up and puts the victims at a disadvantage. But you have to work within the system and have yourself and your neighbors call code compliance every time you are disturbed by loud noise. Code will then generate a report. You should instruct Code to forward the report to the Planning Department to these folks:

When the Planning Dept is made aware of several noise complaints, then they will instruct the venue to appear at the Planning Board for a review of the Conditional Use permit. The board has the power to revoke the permit or modify it to make it more strict.

I attached a screen shot to show you how to input the information to locate the reported noise complaints. Strangely, the address in this system for The rooftop Eatery is 723 N N Lincoln Ln (with two "N"s)

The system shows 31 noise complaints from 2020 to present. Three noise complaints occurred after the Planning Board voted on May 22, 2022 to allow the continuance of rooftop entertainment. You may want to forward these four noise complaints to the Planning Dept with a full description of the abusive ongoing noise you are experiencing from the Eatery venue.

Hello:

Nice to meet you, Gayle. Thank you for the intro Adam. Typically several nights a week I can hear the music from a rooftop bar inside my apartment. I live close to where the mentioned complaint was based. I was told by code enforcement on several

occasions that the noise was coming from the eatery. Unfortunately you sometimes have to let them inside your apartment to get a complaint issued and it's really burdensome to Repeatedly have to do that at 1am. I have had them inside multiple times and they have always verified you could hear the music but I am really tired of doing that especially is nothing is coming from it. I believe something was issued against the Eatery recently, as you could hear the music from the alley. However because of the way the noise travels, it other times you may hear the noise in an apartment and not necessarily on the ground right next to the building.

The code also mentions, I believe, that there are not supposed to be rooftop parties past 8 pm in Residential adjacent buildings.

Separate issue but Euclid Circle is also now doing concerts 3x per week and it's incredibly loud inside the apartment. They cannot face residential

buildings blasting their speakers. It's insane. All of this combined in untenable.

RE: Revocation/Modification of Conditional Use Permit for 723 N Lincoln Lane, Lincoln Eatery

The Planning Board voted 5 to 1 to continue rooftop entertainment conditional use permit. I voted "no" because I believe this rooftop entertainment permit should be immediately revoked. The existing CU required ambient volume with a password protected volume control. There were several noise violations/complaints, including a valid noise violation from a home three blocks away at 1613 Pennsylvania Ave. Ambient volume is defined as a volume that allows casual conversation to be heard.
