- a. The aluminum trellis located in the rooftop shall consist of the same color selection and material as the trellis located on the ground floor entrance.
 - Instinctively, it may be considered to match both trellises. Yet, the design intent was exactly the opposite. And it is to give a differential aspect at the entry to the language proposed at the roof deck. Since design intent sees the new roof top to be a representation condition which flourishes from the interior to the exterior in a Crown-like format. A blossom of the natural feeling that translates to the top like a flower from a stem.
- b. Please submit specific details of the operation of the aluminum panels on the rooftop level. Is this a single retractable panel or multiple panels? -

c. Clarify how the curved portion of the retractable roof will operate. THE FLAT SQUARE AREAS ARE RETRACTABLE. THE CURVED BITS ARE THE ROTATING LOUVER BLADES.
