My husband and I have lived here at Sunset Harbour South for 24 years. In that time we have looked down on the pleasant green roof structure of the current Marine Patrol Station.

When the CIP Project presented to the community a month or so ago I questioned what the roof would look like on the proposed Marine Patrol/Fire Department Structure at that time no one could give us any rendering of the roof, all they could say was there would be equipment on the roof.

I was happy to see from Sara's email that some consideration has been given the covering the equipment and in the renderings there seems to be some nondescript white surface that lacks any detail. As a previous member of the Planning Board and active resident for 24-years, I hope you will all:

- 1. I look to you to examine closely this area and question the city on why, with the City's push to be eco-friendly and the buildings close proximity to the new Gibb Park was there any consideration given to a Green Roof on this building.
- 2. Recognize that the entire south side of Sunset Harbour South has looked down on the current structure for 24 years and the pleasing green roof system allows it to work in harmony with the park any future roofing system should provide the same experience.
- 3. Please ensure that the buildings over all look and feel from all angles is in harmony with the extremely significant new Gibb Park Design.
