APPROXIMATE AMOUNT OF \$144,100; 4) UNITED STATES TENNIS ASSOCIATION FLORIDA SECTION FOUNDATION, IN THE APPROXIMATE AMOUNT OF \$16,000; 5) U.S. DEPARTMENT OF TRANSPORTATION, **FEDERAL TRANSIT** ADMINISTRATION, LOW OR NO EMISSION GRANT PROGRAM AND GRANTS FOR BUSES AND BUS FACILITIES COMPETITIVE PROGRAM, IN THE APPROXIMATE AMOUNT OF \$15.1 MILLION.

WHEREAS, the City Administration requests approval to apply for a grant in the approximate amount of \$144,100 from Department of Energy, Energy Efficient and Conservation Block Grant Program, the details of which are set forth in the Commission Memorandum accompanying this Resolution; and

WHERAS, the City Administration requests approval to apply for two grants in the combined approximate amount of \$16,000 from United States Tennis Association Florida Section Foundation, the details of which are set forth in the Commission Memorandum accompanying this Resolution; and

WHERAS, the City Administration requests approval to apply for a grant in the approximate amount of \$15.1 Million from U.S. Department of Transportation, Federal

Transit Administration, Low or No Emission Grant Program and Grants for Buses and Bus Facilities Competitive Program, the details of which are set forth in the Commission Memorandum accompanying this Resolution, including City matching funds in the approximate amount of \$2.6 Million, contingent on approval during the FY24 capital budget process.
