Staff was asked to investigate a percentage escalation cap option to control service fees and the possibility of adding bulk pickup. Waste haulers would be required to provide the city with a quarterly report on service issues. Should the Waste Hauler company come across a hardship, the Commission could grant a hardship Waiver, so the waste haulers are not operating at a loss. The RFQ process was to include the Waste Haulers having 90-days to inform customers of any fee changes prior to the contract expiration, along with the homeowners having 60 days to respond if they would like their service canceled. The term of the contract should be 2 years for bins, and 5 years otherwise. Staff were also asked to produce the terms of the contract. Commissioner Fernandez seconded the motion. All in favor.

Staff was directed to bring forth a discussion of waste hauler brokers at the next Commission meeting.
