A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, APPROVING A GRANT IN THE AMOUNT OF \$10,000 TO THE LINCOLN ROAD BUSINESS IMPROVEMENT DISTRICT FOR THE PREMIER OF ZORRO, AND AUTHORIZING THE CITY CLERK AND CITY MANAGER TO EXECUTE THE CITY'S STANDARD GRANT AGREEMENT WITH RESPECT TO THE FOREGOING; AND FURTHER, WAIVING PERMITTING FEES AND COSTS ASSOCIATED WITH THE EVENT, IN THE AMOUNT NOT TO EXCEED \$9,072.

WHEREAS, *Zorro* is an upcoming Spanish action-adventure series produced by Secuoya Studio and starring Miguel Bernadeau, which will air on Amazon Prime Video in the first half of 2024 in Latin America, the U.S., Spain, Andorra and Portugal; and

WHEREAS, the series premiere is scheduled to take place on January 18th, 2024, in Regal South Beach movie theater on Lincoln Road, in the City of Miami Beach; and

WHEREAS, the series premiere taking place in the City will attract great publicity for the City, and will be a family friendly event; and

WHEREAS, the Greater Miami Convection and Visitors Bureau (GMCVB) has agreed to contribute hotel rooms for the cast and crew, and the Lincoln Road Business Improvement District (Lincoln Road BID) has agreed to contribute financial support for the theater costs; and

WHEREAS, the Mayor and City Commission wish to allocate a one-time grant in the total amount of \$10,000 to the Lincoln Road BID, to help offset theater costs, and waive permitting fees and other costs associated with the event, attached to this Resolution, in the amount not to exceed \$9,072.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby approve a grant in the amount of \$10,000 to the Lincoln Road Business Improvement District for the premier of Zorro, and authorize the City Clerk and City Manager to execute the City's standard grant agreement with respect to the foregoing; and further, waive permitting fees and costs associated with the event, in the amount not to exceed \$9,072.
