#### **ANALYSIS**

Please place on the February 21, 2024 agenda a referral to the Public Safety and Neighborhood Quality of Life Committee to discuss a revision to our current process for handling fines and penalties for signage and other small City Code violations. Specifically, I suggest transitioning from the current Special Magistrate process to an automatic fine system based on best practices and set by the City Commission, in order to streamline the process for these quality of life violations.

I believe that adopting an automatic fine system for small violations would improve the efficiency of our enforcement process, resulting in faster resolution of these nuisance violations which would both enhance the quality of life for residents, and indicate to violators that nuisance violations need to be resolved expeditiously. As part of this referral, I would ask for the Code Compliance Department and City Attorney's Office to be prepared to identify and discuss those violations in Chapter 58 and the City's Land Development Regulations that have an immediate, fixed fine vs. those fines that require an adjudication by the Special Magistrate prior to imposition of the fine for a violation of the City Code; and to propose a schedule of fines based on best practices.
