A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, RESPECTFULLY URGING THE MIAMI-DADE SCHOOL BOARD TO SELECT FRIENDS OF SOUTH POINTE ELEMENTARY SCHOOL AND NORTH BEACH PTA TO MANAGE THE AFTER-SCHOOL ENRICHMENT PROGRAMS AT SOUTH POINTE ELEMENTARY SCHOOL AND NORTH BEACH ELEMENTARY SCHOOL, RESPECTIVELY, IN RECOGNITION OF THEIR DEMONSTRATED EFFECTIVENESS, COMMUNITY SUPPORT, AND COMMITMENT TO THE EDUCATIONAL SUCCESS OF ALL STUDENTS.

WHEREAS, the City of Miami Beach recognizes the critical importance of enriching educational experiences beyond the standard curriculum; and

WHEREAS, the Friends of South Pointe Elementary School and North Beach Parent-Teacher Association (PTA) have demonstrated a longstanding commitment to enhancing the educational opportunities for students through their respective after-school enrichment programs; and

WHEREAS, both organizations have been instrumental in maintaining the high quality and successful track record of their respective after-school enrichment programs, contributing significantly to the overall educational experience and reputation of South Pointe Elementary School and North Beach Elementary School; and

WHEREAS, the track record of each respective enrichment program is a leading reason why many Miami Beach families send their children to public school and choose to live in Miami Beach; and

WHEREAS, the leadership of both Friends of South Pointe Elementary School and North Beach PTA comprises of dedicated and involved parents who are deeply invested in the educational welfare of the students at their respective schools; and

WHEREAS, moving away from the current structure that involves the parents and community could have a material impact on fundraising efforts that support these programs; and

WHEREAS, for these reasons, the Mayor and City Commission respectfully urge the Miami-Dade School Board to select Friends of South Pointe Elementary School and North Beach PTA to manage the after-school enrichment programs at South Pointe Elementary School and North Beach Elementary School, respectively, recognizing their demonstrated effectiveness, community support, and commitment to the educational success of all students.
