A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, AUTHORIZING THE CITY OF MIAMI BEACH TO ACCEPT DONATIONS AND SPONSORSHIPS FROM BAPTIST HEALTH SOUTH FLORIDA, INC., AND T-MOBILE USA, INC., IN THE TOTAL AMOUNT OF \$26,000, FOR THE 2017 HISPANIC HERITAGE FESTIVAL, THE 2017 WINTER WONDERLAND EVENT, AND THE UNIFORMS FOR THE CITY'S PARKS AND RECREATION DEPARTMENT'S YOUTH BASKETBALL LEAGUE, YOUTH TRAVEL SOCCER LEAGUE, AND THE SILVER SLUGGERS SENIOR SOFTBALL LEAGUE; AND, FURTHER, AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE, TO MAKE SUCH EXPENDITURES AND/OR REIMBURSEMENTS CONSISTENT WITH THE AFORESTATED EVENTS AND PURPOSES.

WHEREAS, the City of Miami Beach hosts an annual Hispanic Heritage Festival, and an annual Winter Wonderland Event, and further supports the City's Parks and Recreation Department's youth basketball and travel soccer leagues, as well as the Silver Sluggers senior softball league; and

WHEREAS, these events bring hundreds of volunteers together to engage the community in projects that provide free outdoor entertainment and promote the celebration of the Hispanic culture, the holiday season, and an active and healthy lifestyle; and

WHEREAS, City staff has worked diligently to identify funding sources to off-set the costs of producing these events, and the costs of athletic uniforms needed for the aforementioned basketball, soccer, and softball leagues, and has secured partnerships through sponsorships at varying levels of support from Baptist Health South Florida, Inc., and T-Mobile USA, Inc.; and

WHEREAS, the City Administration recommends the acceptance of sponsorships from the above-referenced sponsors, in the total amount of \$26,000, to cover the costs of the 2017 Hispanic Heritage Festival, the 2017 Winter Wonderland Event, and the uniforms for the City's Parks and Recreation Department's youth basketball league, youth travel soccer league, as well as the Silver Slugger senior softball league; and

WHEREAS, the City Administration recommends that the City Commission authorize the City Manager, or his designee, to make any necessary reimbursements and/or expenditures of the aforementioned donations, in furtherance of, and consistent with, the aforementioned events and purposes.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby authorize the City of Miami Beach to accept donations and sponsorships from Baptist Health South Florida, Inc., and T-Mobile USA, Inc. in the total amount of \$26,000, for the 2017 Hispanic Heritage Festival, the 2017 Winter Wonderland Event, and the uniforms for the City's Parks and Recreation Department's youth basketball league, youth travel soccer league, as well as the Silver Slugger senior softball league; and, further, authorize the City Manager, or his designee, to make such expenditures and/or reimbursements consistent with the aforesated events and purposes.
