A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, APPROVING, IN CONCEPT, THE RECOMMENDATION FROM THE EMPLOYEE SUGGESTION PROGRAM TO INSTALL MOTION SENSORS FOR LIGHTING IN CITY BUILDINGS, AND DIRECTING THE CITY MANAGER TO INVESTIGATE THE COSTS AND FEASIBILITY OF IMPLEMENTING SUCH SUGGESTION AND TO REPORT HIS FINDINGS TO THE CITY COMMISSION.

WHEREAS, the Employee Suggestion program ("Program") is one of the City's five Reward and Recognition programs implemented June 16, 2015. This Program allows employees to share innovative ideas, which may enhance productivity, efficiency, effectiveness, safety, and/or the quality of local government services; and

WHEREAS, at the end of each Fiscal Year ("FY"), additional prizes are awarded based on a recommendation from the Program's Procedure team, including intangible recommendations; one award of \$1,000 goes to an employee for the suggestion of the year resulting in cost savings/revenues for the City, and up to three other awards go to the runners-up at \$500 each; and

WHEREAS, for FY 2017, a suggestion to install Motion Sensors for lighting in City Buildings was selected for an award of \$1000 and possible implementation; and

WHEREAS, currently, there are no City buildings with motion sensors that control lighting; and

WHEREAS, the Sustainability and Resiliency Committee ("SRC") is scheduled to meet October 30th to discuss a proposal from one of the City's Architectural and Engineering rotational companies, Glavovic Studio, assessing the costs for retrofits to achieve LEED Existing Buildings Operational Maintenance ("EBOM") baseline certification for the three previously selected municipal properties: The Art Deco Welcome Center, South Shore Community Center, and Fire Station No. 3. Motion sensors could count as credits (points) towards the LEED EBOM certification; and

WHEREAS, motion sensors that control lighting may have a potential cost savings, deter criminal activity, and conserve energy; and

WHEREAS, the following the City buildings located at 1833 Bay Rd, 1755 Meridian, and the Exterior of City Hall are on a schedule where all lights turn off via a Lutron panel, therefore these areas would not need occupancy motion sensors.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby approve, in concept, the recommendation from the Employee Suggestion Program to install Motion Sensors for lighting in City Buildings and direct the City Manager to investigate the costs and feasibility of such suggestion and to report his findings to the City Commission.

WHEREAS, if recommended for implementation, funding would need to be identified and artist selection would follow the Art in Public Places Selection Process, which also includes review by the Historic Preservation Board/Design Review Board, as applicable; and, agreements may be required with other entities; and

WHEREAS, a recommendation was received from the City's Chief Learning and Development Officer to partner with Miami Beach schools and Parent Teacher Student Associations (PTSA) to consider designs done by our youth; and

WHEREAS, a recommendation was also received from the Public Works Director to place ads on the traffic control boxes, as a way to ensure the project is self-sustaining.

WHEREAS, the Employee Suggestion program ("Program") is one of the City's five Reward and Recognition programs implemented June 16, 2015. This Program allows employees to share innovative ideas, which may enhance productivity, efficiency, effectiveness, safety, and/or the quality of local government services; and

WHEREAS, at the end of each Fiscal Year ("FY"), prizes are awarded based on a recommendation from the Program's Procedure team, including intangible recommendations; one award of \$1,000 goes to an employee for the suggestion of the year resulting in cost savings/revenues for the City, and up to three other awards go to the runners-up at \$500 each; and

WHEREAS, for FY 2017, a suggestion to change the flow of traffic in the City Hall Garage was selected for an award of \$500 and possible implementation; and

WHEREAS, each floor in the City Hall garage has an up/down ramp and two (West and East) paths to continue to other floors; and

WHEREAS, to ensure safety, it is recommended to use one lane (West Lane) to come up and the other (East Lane) to come down; and

WHEREAS, the printing and installing of signage could be implemented by the Parking Department; and

WHEREAS, it has been determined that installing speed limit signs throughout the garage instead of changing the flow of traffic, would be a more immediate solution; and

WHEREAS, potential benefits include less accidents and increased safety.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA that the Mayor and City Commission hereby approve, in concept, the recommendation from the Employee Suggestion Program to change the traffic flow in the City Hall garage and direct the City Manager to investigate the costs and feasibility of implementing such suggestion and to report his findings to the City Commission.
