RE: Street-end of 34th Street parking lot – Faena Fountain

Our firm represents 3425 Collins, LLC ("Applicant") who is proposing to donate the artwork "Faena Fountain" (the "Fountain") to the City and to install and maintain the Fountain at the sole cost of the Applicant in the street-end of the 34 Street parking lot as depicted in the enclosed plans. The Applicant is the owner of the adjacent property at 3425 Collins Avenue (the Versailles) and the 34 Street parking lot is in the middle of the Faena District – the Faena House condominium and Faena Hotel lie to the south of 34 Street and the Forum, Bazaar and Claridge Hotel are on the west side of Collins Avenue across from the 34 Street parking lot. The central location to the Faena District makes the street-end an ideal location for an iconic fountain artwork.

The Fountain requires a certificate of appropriateness ("COA") from the Historic Preservation Board. It also requires review by the Art in Public Places ("AiPP") Committee, the Neighborhood & Community Affairs Committee and the City Commission. At the time this application was submitted the Art in Public Places committee has not reviewed the request (it is on the October 18 agenda) to place the Fountain in the 34 Street parking lot street-end but by the time this application is heard by the HPB the AiPP committee will have opined on it. The same is true for the Neighborhood & Community Affairs Committee, which is scheduled for October 27.

The Fountain was created by Studio Job. Studio Job was founded in 2000 by Job Smeets and Nynke Tynagel, both graduates of the venerated Design Academy Eindhoven. Their collaboration has created highly expressive, mainly one-off or limited-edition works, redefining the applied arts for the contemporary age. Studio Job's work is widely exhibited in New York, Tokyo, Los Angeles, Paris, London, Milan, Miami, Shanghai, Abu Dhabi and Basel, and their designs are in the collections of more than 40 museums worldwide.

Over the past four years, the Antwerp-based design collective has collaborated with Faena on custom symbology that appears on pavement, fences, wallpaper, sculptures, printed material, and banners throughout Faena District Miami Beach. Their commissions also include a decorative fence around the perimeter of the Versailles property, which features symbols of imagination, life,

passion, and transformation—ideas central to the Faena Universe. The Faena Fountain, and its "sister" creation the "Tree of Life" sculpture (installed at the Forum, at the SW corner of 34 Street and Collins Avenue), explores man's search for spiritual and physical renewal.

The Fountain would be located prominently in the center of the street-end park, equidistant from the two abutting properties, approximately 63' from the rear property line abutting the beachwalk and approximately 300' from Collins Avenue. When viewing the Fountain from the beachwalk, one will be able to look past the Fountain and also see the Tree of Life – two works of art by the same artist, expressing central ideas to the Faena mission. Also, the Fountain will serve as a "gateway" work of art for the public pedestrian connection from the beachwalk to Collins Avenue, much like the Gone But Not Forgotten work of art serves as a now iconic gateway work of art which, although located on private property, is visible from the 32 Street street-end and beachwalk as you enter the Faena District. See the next page for a depiction of the location of the Fountain in relation to the Tree of Life and Gone But Not Forgotten works of art.


The Fountain would sit on a concrete foundation that is 6'-6" square and 3'-3" deep. The Fountain is 16' tall and the basin that collects the water has a diameter of approximately 8.2'. The Fountain basin slides on top of a steel structure that is mounted onto the concrete base with six (6), 6-inch long bolts. The basin is made from a technical foam hardened with polyester and cladded with silver colored mosaic tiles. The Fountain would be hurricane resistant. All of the bolts used in the Fountain are stainless steel. The crown and the lower base are made of bronze. The whale and the top water "shield" and the hands are made of aluminum. The sculpture will be lighted at night with landscaping up-lights that are similar to the lights used throughout the Faena properties to light the landscaping.

Previously on February 10, 2015 the HPB approved File No. 7510, which permitted the installation of non-standard paving and landscaping throughout the public rights-of-way in the Faena District, including the street-end of 34 Street. In connection with the approval of the non-standard improvements Faena entered into a covenant with the City specifying that Faena is responsible for the cost of the installation and maintenance of all of the non-standard improvements. Although the Applicant is proposing to donate the Fountain to the City, the Applicant will pay for 100% of the cost of installation and maintenance of the Fountain.

We submit that the Fountain is an interesting and suitable element for the Faena District and will help convey the theme of the Faena District in an artistic way that is appropriate. We respectfully request the Historic Preservation Board's favorable review of the request.



The City of Miami Beach Historic Preservation Board makes the following FINDINGS OF FACT, based upon the evidence, information, testimony and materials presented at the public hearing and which are part of the record for this matter:

I. Certificate of Appropriateness

A. The subject site is located within the Collins Waterfront Local Historic District.

B. Based on the plans and documents submitted with the application, testimony and information provided by the applicant, and the reasons set forth in the Planning Department Staff Report, the project as submitted:

1. Is consistent with the Certificate of Appropriateness Criteria in Section 118-564(a)(1) of the Miami Beach Code.

- 2. Is consistent with Certificate of Appropriateness Criteria in Section 118-564(a)(2) of the Miami Beach Code.
- 3. Is consistent with Certificate of Appropriateness Criteria "b', 'c' & 'g' in Section 118-564(a)(3) of the Miami Beach Code.
- C. The project would remain consistent with the criteria and requirements of section 118-564 if the following conditions are met:
 - 1. Revised elevation, site plan and floor plan drawings shall be submitted and, at a minimum, such drawings shall incorporate the following:
 - a. The proposed paving design for the areas immediately adjacent to the standard 'Miami Beach Red' sidewalks shall be further developed in a manner which creates a more seamless transition, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - b. Final details of all exterior surface finishes and materials, including samples, shall be submitted, in a manner to be reviewed and approved by staff consistent with the Certificate of Appropriateness Criteria and/or the directions from the Board.
 - 2. The applicant shall submit a restrictive covenant agreeing to design, construct and maintain in perpetuity, the sidewalk as proposed, including bearing all costs associated with the design, construction and maintenance of the sidewalk, in a manner to be reviewed and approved by the Public Works Director and City Attorney. The covenant shall be recorded in the Public Records of Miami-Dade County, prior to the issuance of a Building Permit.

In accordance with Section 118-537, the applicant, the owner(s) of the subject property, the City Manager, Miami Design Preservation League, Dade Heritage Trust, or an affected person may appeal the Board's decision on a Certificate of Appropriateness to a special master appointed by the City Commission.

II. Variance(s)

A. No variance(s) were filed as part of this application.

III. General Terms and Conditions applying to both 'I. Certificate of Appropriateness' and 'II. Variances' noted above.

A. A copy of all pages of the recorded Final Order shall be scanned into the plans submitted for building permit, and shall be located immediately after the front cover page of the permit plans.

B. The Final Order shall be recorded in the Public Records of Miami-Dade County, prior to the issuance of a Building Permit.

- C. Satisfaction of all conditions is required for the Planning Department to give its approval on a Certificate of Occupancy; a Temporary Certificate of Occupancy or Partial Certificate of Occupancy may also be conditionally granted Planning Departmental approval.
- D. The Final Order is not severable, and if any provision or condition hereof is held void or unconstitutional in a final decision by a court of competent jurisdiction, the order shall be returned to the Board for reconsideration as to whether the order meets the criteria for approval absent the stricken provision or condition, and/or it is appropriate to modify the remaining conditions or impose new conditions.
- E. The conditions of approval herein are binding on the applicant, the property's owners, operators, and all successors in interest and assigns.
- F. Nothing in this order authorizes a violation of the City Code or other applicable law, nor allows a relaxation of any requirement or standard set forth in the City Code.

IT IS HEREBY ORDERED, based upon the foregoing findings of fact, the evidence, information, testimony and materials presented at the public hearing, which are part of the record for this matter, and the staff report and analysis, which are adopted herein, including the staff recommendations, which were adopted by the Board, that the Certificate of Appropriateness is GRANTED for the above-referenced project subject to those certain conditions specified in Paragraph I, II,III of the Findings of Fact, to which the applicant has agreed.

PROVIDED, the applicant shall build substantially in accordance with the plans approved by the Historic Preservation Board, as determined by staff, entitled "Faena District Miami Beach" as prepared by Jungles Landscape Architecture, dated November 2014.

When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Order. No building permit may be issued unless and until all conditions of approval that must be satisfied prior to permit issuance, as set forth in this Order, have been met.

The issuance of a Certificate of Appropriateness does not relieve the applicant from obtaining all other required Municipal, County and/or State reviews and permits, including final zoning approval. If adequate handicapped access is not provided on the Board-approved plans, this approval does not mean that such handicapped access is not required. When requesting a building permit, the plans submitted to the Building Department for permit shall be consistent with the plans approved by the Board, modified in accordance with the conditions set forth in this Order.

If the Full Building Permit for the project is not issued within eighteen (18) months of the meeting date at which the original Certificate of Appropriateness was granted, the Certificate of Appropriateness will expire and become null and void. If the Full Building Permit for the project should expire for any reason (including but not limited to construction not commencing and continuing, with required inspections, in accordance with the applicable Building Code), the Certificate of Appropriateness will expire and become null and void.
