Dear Tom:

This firm represents Harding Excalibur, LLC (the "Applicant") the owner of an assemblage of land located on the east side of Harding Avenue between 80 Street and 81 Street. Please consider this letter the Applicant's amended letter of intent in support of an application for design approval for an innovative hotel development. The largest amendment to the submitted plans is that the Applicant is now proposing to maintain the existing building at 8035 Harding as part of the project. The retention of the building has resulted in the need for two new setback variances to accommodate the existing building.

<u>The Property.</u> The project spans the following addresses: 8011, 8017, 8021, and 8035 Harding Avenue (hereinafter "the Property"). The Property is zoned Residential Multifamily (RM-1) under the City's land development regulations and is located in the North Shore National Register Historic District.

The subject property is developed with four buildings of varying ages as well as an empty lot. Of the buildings on the site, 8035 Harding clearly has the best architectural value, being a good example of streamline moderne design. Thomas Mooney, Director May 20, 2016 Page 2

<u>Proposed Development.</u> The Applicant proposes to develop the Property with an innovative hotel with ground level covered parking.

<u>Variances</u>. The Applicant had previously requested variances for the new construction but has been able to remove all variances associated with the new building. However, the need to accommodate 8035 Harding into the design will create two setback variances related to the placement of the existing building.

The variances are as follows:

- 1. An interior side setback pedestal variance to permit the existing building to locate 5.3' from the north property line.
- 2. A front setback pedestal variance to permit the existing building to locate 16.8' the west property line.

<u>Code Standards.</u> The relevant listed standards in Section 118-353(d) are below and will be followed by a brief analysis.

(1) special conditions exist that are peculiar to the applicant's land;

This site is uniquely burdened by the existing 8035 building. In order to retain that existing structure as part of the plan, the requested variances will be needed.

(2) the special conditions were not created by the applicant;

The Applicant did not create the special conditions inflicted on the Property.

(3) granting the requested variance would not confer upon the applicant special privileges;

The approval of the requested variances will only serve to allow the Applicant to retain an existing building that, while not designated historic by the City, has unique qualities that should be protected.

(4) literal application of the City's standards would result in unnecessary and undue hardship;

As recognized multiple times by the City, the need to accommodate historic buildings in a redevelopment plan can create a hardship that will justify a variance. This application represents a classic case, where the variances are sought only to retain the existing structure's building lines.

(5) the variance would be the minimum necessary for a reasonable use of the land, building, or structure;

The requested variances are the minimum needed to develop a project that retains the existing building.

(6) the variance would be in harmony with the general intent of the City's regulations; and

The approval of the requested variances would permit the development of an innovative and compatible on this Property. It is also consistent with the goal of encouraging the adaptive re-use of buildings.

(7) the granting of the variance would be consistent with the City's comprehensive plan and does not reduce minimum levels of service established in the comprehensive plan.

The requested variances will keep the development consistent with the Comprehensive Plan and will not intensify the development of the land in a manner inconsistent with established levels of service.


