This three story building was designed IN THE MIMO ARCHIby the Architect Alexander Lewis in 1947. It was originally constructed as an apartment house with 16 one-bedroom and 14 efficiency apartments plus 5 hotel rooms at an original cost of \$125,000.00 according to the Building Card. It is constructed on spread concrete footings. The certificate of Occupancy was granted on January 12, 1948.

The original name for the building was the Malabo Apartments. It is unclear from where this name originated. The area on the Building card is blacked out where the original owner's name would appear.

It was typical in those days on Miami Beach for owners to name their buildings in honor of perhaps the owner and his wife. We do not know if this is the case here.

However the name 'Malabo' is also the name of the capital city of the country of Equatorial Guinea and is located on the north coast of the island of Bioko, off the African coast. The island was formerly known as Bubis and also as Fernando Poo. The city was renamed as Malabo in 1973. Thus it was not the source of the name of this building...yet an interesting factoid..

The building features a tripartite elevation-mass facing Indian Creek Drive. The two north and south sections slightly protrude from the center section. This helps to minimize the length of the facade. Each of these protruding sections contains three vertical window surrounds which act as the building's decoration. The roofline at the top of the parapet is also highlighted in a similar type of accent - although in a horizontal manner.

The first floor corner of 39th and Indian Creek Drive contains significantly more full height glazing to denote the lobby location. Outside of the lobby on the first floor is an exterior raised terrace which runs partly along 39th Street and partly along Indian Creek Drive. The historic photos of the building show that the existing railing is not the original railing. However the Building Card does not show any entry regarding the replacement of the terrace railings. In any event these railings may need to be replaced and / or modified in order to comply with newer codes.

The elevation along 39th street is composed of three window vertical surrounds as similarly appears along Indian Creek Drive.
