

Dear Mr. Mooney and Planning Board Members,

The North Shore Bandshell was designed and constructed by Norman Giller in 1961. Originally named the North Shore Oceanfront Community Center, the bandshell remains an iconic and recognizable image associated with the North Beach community.

For a majority of its existence, the North Shore Bandshell has been under the supervision and control of the City of Miami Beach Parks and Recreation Department. For years it was managed the same way the city manages its park pavilions.

Between 2011 and 2014 the Bandshell and surrounding park underwent significant renovations. This included the construction of the new North Beach Oceanfront Community Center. The combined purpose of these improvements was to bring activation to an underutilized oceanfront park which would service the community and to activate the surrounding commercial districts.

In 2014 there was a recommendation, from the now sunset Mayor's Blue Ribbon Panel on North Beach, to issue an RFP for the management of the North Shore Bandshell. The Rhythm Foundation was awarded the management agreement for the facility. In its 1st year of operations and under the management of the Rhythm Foundation, the bandshell hosted 66 events, of which 44 were free to the community, bringing an estimated 32,000 visitors. The community support for the programming at the North Shore Bandshell has come to symbolize the revitalization efforts in North Beach.

At this time the Rhythm Foundation is seeking to formalize its licensing requirements for the operations of the North Shore Bandshell. There has never been a Business Tax Receipt (BTR) issued for this facility. This site is currently zoned GU. The city planning department has determined the need for the Rhythm Foundation to seek a waiver for a Neighborhood Impact and Outdoor Entertainment Establishment in order to approve the Business Tax Receipt application as a Hall for Hire use.

The Rhythm Foundation is seeking Planning Board approval to meet its contractual obligations to provide community programming and support the ongoing revitalizations efforts in North Beach. These waivers are required in order to obtain the local BTR and apply for the State License as a Performing Arts Center (11PA), available only to non-profit organizations. Without the approval of the Planning Board, the Rhythm Foundation can not obtain the required BTR and can not continue to provide community programming at the North Shore Bandshell.

Please find below a brief outline for the current operational structure of the North Shore Bandshell under the management of the Rhythm Foundation.

In-House Sound System

The City of Miami Beach designed and installed an in-house sound system to be used for all events at the bandshell. The city conducted a sound study surrounding the bandshell, inclusive of the two residential towers nearby. The current system purchased by the city was designed as a result of the study to insure minimal sound overflow that could impact area residents. The use of the in-house sound system (specifically designed to minimize the amount of sound escaping the venue & focus the sound within the audience area) is strictly enforced. Sound levels are not to exceed 105dBC at any time. All speakers are installed calibrated and tuned each time an event takes place. All subwoofers are specifically arranged as to minimize the distance the low frequencies can travel. Overall the sound system is state of the art and provides the controls needs to insure the noise levels are maintained in accordance with the guidelines set forth by the City of Miami Beach.

Notice Requirement

In order to insure both the city administration and area residents are informed of upcoming events, 30 days written notice is issued to the surrounding neighborhood as well as all relevant City personnel and departments detailing the nature of the event and the planned use of the sound system. This notification is sent to almost all city departments including, City Manager, Parks & Recs, Code Compliance, Police Department, Economic Development and many more. The same notice is sent to area businesses and residents.

Hours of Operation

The hours of operations are set by the city administration and commission. A curfew of 10 PM is strictly enforced on events. The City Manager does have the discretion to extend the hours of operation on a case by case basis to 11 PM on the weekends (Saturday and Friday) and requires the signed approval of the City Manager for the extension of hours until 11 PM only. There is no possibility to request operating hours beyond 11 PM for any event.

Concessions and Alcoholic Sales

Crown Concepts provides the catering services for the North Shore Bandshell, including the sale of alcohol. Currently, the process begins with the City of Miami Beach approving the license and COI (Certificate of Insurance), including Liquor Liability Insurance. Alcohol is sold only during event operations by their trained staff. When an individual comes to an event at the Bandshell they are greeted by Security personnel who enforce the house rules and check all bags. No outside food or drinks are allowed in the venue, leaving the venue with alcoholic beverages is strictly prohibited.

Age verification is done at the point of entrance for the venue, with clearly marked 'Over 21' wristbands issued only to those over legal drinking age, wristbands stating 'Under 21' are issued for all other guests showing that they have been screened through security.

Monthly Committee Meetings

One the first Wednesday of each month the Rhythm Foundation hosts a committee meeting to discuss the operations of the facility. This committee is comprised of Rhythm Foundation staff, local residents, business owners, users of the facility, CMB Parks and Recreations, Unidad and others. The purpose of the monthly meeting is to review and discuss the operations for the coming months and obtain input from individuals on future planning and events.

We appreciate your consideration and review of our application. We are available to provide any additional information you may require or is requested by any of the planning board members. We are available to coordinate onsite visits for staff and planning board members at their convenience. It would be ideal to have the board members attend any of our upcoming events prior to the June hearing. We would like to extend this invitation to all board members.


