SUBJECT: POLICE AND PARKING DEPARTMENT TOWING PERMITS DISCUSSION ITEM - WALKER

PARKING SUPPLEMENTAL REPORT

Supplemental Information

On November 30, 2018, Mr. Ralph Andrade, legal counsel for the two towing service providers sent a correspondence (see attached) requesting the City and Walker Parking consider two points related to the analysis submitted by Walker. The two issues are:

- Comingling of maximum allowable towing rates in municipalities and counties skews the average tow rate provided in the report; and
- Miami Beach's tow permit fee (\$30 per tow) is included in the current maximum tow rate of \$140 for Class "A" tows which results in a net maximum rate of \$110.

The Administration forwarded Mr. Andrade's inquiry to Walker Parking for their further review and response. Walker provided a supplemental report (see attached) containing the following updated recommendation:

Walker recommends the City of Miami Beach amend its maximum allowable towing rates for non-consensual tows to remain consistent with the towing ordinance rates defined under Miami-Dade County. Additional fees per tow, charged to the motorist and made payable to the City of Miami Beach, should be in addition to an amended maximum allowable towing rate of \$120.50 per tow. Hence, increasing the existing non-consensual tow for non-residents from \$140 to \$150.50 and for residents from \$140 to \$145.50. Similar to other South Florida Region jurisdictions, the City of Miami Beach should review its towing rates on an annual basis to remain consistent with its neighboring municipalities and counties.

Walker's updated recommendation results in a net increase of \$10.50 per tow, a 7.5% increase, which is consistent with the 9.8% cumulative CPI increase between December 2012 and August 2018 (see attached Towing CPI analysis).

Please note the City's Internal Auditor is conducting an audit of both towing service providers. The audit report is anticipated to be completed by January 2019.

The Administration is seeking direction regarding this item.

EXECUTIVE SUMMARY

Walker's research efforts have identified the maximum allowable towing rates and administrative fees associated with non-consensual police directed tows for the following sample survey of municipalities:

Municipality	Non-consensual towing rate – Class A
City of Daytona Beach	\$125
City of Key West	\$135
City of Miami	\$120.50
City of Panama City Beach	\$87.50
City of Tampa	\$125
City of West Palm Beach	\$167

The average maximum towing rate for these municipalities is \$126.66 per tow.

During our research efforts, we quickly recognized a significant number of the municipal jurisdictions throughout the state of Florida defer to their respective county jurisdictions when establishing maximum towing rates and fees. In the case of the municipalities we listed above, the following counties have assumed the greater role when defining maximum allowable towing rates:

County	Non-consensual towing rate – Class A
Monroe County	\$135
Miami-Dade County	\$120.5
Hillsborough County	\$125
Palm Beach County	\$167

The average maximum towing rate for these counties is \$136.88 per tow.

Relevant to the findings associated with this revised document, Walker compared the maximum allowable towing rates for the following relevant counties defined under a South Florida Region grouping:

County	Non-consensual towing rate – Class A
Monroe County	\$135
Miami-Dade County	\$120.5
Broward County	\$137.28
Palm Beach County	\$167

The average maximum allowable towing rates for this South Florida Region county grouping is \$139.95.







Key Finding:

Under these counties, additional administrative fees imposed on the motorist and payable to the local municipality include a \$30 per tow for the City of Miami and a \$30 per tow for the City of Miami Beach (\$25 per tow for residents).

Under the City of Miami's towing contract with its towing agencies, the City of Miami has specified that they will charge a fee of \$30 for each vehicle that is recovered, towed, removed, or stored within the City. To administer this policy, the City sends a monthly settlement invoice to each towing agency for payment of the City's fee for each vehicle. The City may charge a late fee in the amount of \$525 if payment is not received from the towing agency within 15 days of receipt of the invoice. If the towing agency has not paid their settlement invoice after 30 days of receipt of the invoice, the City may suspend the towing agencies license. This \$30 fee is in addition to the maximum allowable towing fee received by the towing agency.

By contrast the City of Miami Beach receives a \$30 fee for each vehicle towed and a \$25 fee for each resident-owned vehicle towed. These contractual fees are included in the flat rate towing fee and passed through to the customer. This \$30 reduction to the \$140 non-consensual towing rate for the City of Miami Beach allows \$110 per tow to be retained by the towing agency contractor.

RECOMMENDATION

Walker recommends the City of Miami Beach amend its maximum allowable towing rates for non-consensual tows to remain consistent with the towing ordinance rates defined under Miami-Dade County. Additional fees per tow, charged to the motorist and made payable to the City of Miami Beach, should be in addition to an amended maximum allowable towing rate of \$120.50 per tow. Hence, increasing the existing non-consensual tow for non-residents from \$140 to \$150.50 and for residents from \$140 to \$145.50. Similar to other South Florida Region jurisdictions, the City of Miami Beach should review its towing rates on an annual basis to remain consistent with its neighboring municipalities and counties.







INTRODUCTION

The City of Miami Beach has requested Walker Consultants to analyze their maximum allowable towing rates as well as acceptable forms of payment by the general public to the towing service providers for retrieval of their vehicle. The last towing rate increase in the City of Miami Beach occurred in 2012. The City is seeking a review of the existing rate structure and a comparative analysis with other communities in the region to arrive at a recommendation for maximum allowable towing rates. Walker has chosen nine comparable communities that experience an increase in visitors during peak season activity as well as host an active night life.

Within this analysis, maximum allowable towing rates include non-consensual and police-directed towing rates by vehicle class, drop fees, storage rates, additional fees that can include administrative fees, after-hours fees, or labor fees, and typically define acceptable forms of payment.

DEFINITION OF TERMS

Several terms or jargon are used in this report that have unique meanings when used in the parking industry. To help clarify these terms and enhance understanding by the reader, the following definitions are presented.

- **Non-Consensual or Non-Consent Tow** The towing or removing of any motor vehicle from private property without the express consent of the vehicle owner.
- GVW Gross Vehicle Weight
- Class A Vehicle- Gross vehicle weight up to 10,000 pounds, a sedan to a pickup truck
- Class B Vehicle Gross vehicle weight between 10,000 and 19,500 pounds, box truck to a large walk-in van
- Class C Vehicle- Gross vehicle weight between 19,500 and 25,000 pounds, a beverage truck to a school bus
- Class D Vehicle Gross vehicle weight over 25,000 pounds, a garbage truck to a city transit bus



CITY OF MIAMI BEACH MAXIMUM ALLOWABLE TOWING RATES

The City of Miami Beach's maximum allowable towing rates reflect the rates last updated in 2012. Currently payment is accepted in the form of cash, money order, traveler's check, or personal check. Typical fees commonly found in other municipal rate structures include drop fee, labor rate, administrative fee, and maximum after-hour gate fee. Our research concluded these fees are consistent with other Florida agencies included in this study. The non-consensual tow rate for Class A Vehicles higher than the average rate from the communities studied in this analysis, however Class B, C, and D vehicles are reported at much lower rates than comparable communities. The City has chosen to waive drop fees within City limits, which is unique when compared to the other agencies studied in this analysis.

When researching, Walker found that many municipalities created ordinances that defer to the county's established towing ordinances. Where a city and county are listed in tandem, the city has specified that they have adopted the towing rates set forth by the county. The comparative cities and counties specify in their Code of Ordinances that rates can be altered, revised, increased or decreased as established by their respective commissions. The typical rate increase discovered in this analysis is either the annual percentage increase of the Consumer Price Index or 3%, whichever is lower. The following exhibit shows the maximum allowable towing rates for the City of Miami Beach.

COMPARATIVE CITIES AND COUNTIES


A key part of this study involved a comparison between the City of Miami Beach's towing rates to those of comparable cities and counties throughout the State of Florida. The purpose of this benchmarking exercise is to demonstrate how similar cities haves structured their rates for non-consensual towing operations. The following cities and counties have been chosen to analyze:

- 1. Broward County
- 2. Daytona Beach
- 3. Key West
- 4. Miami Miami-Dade County
- 5. Monroe County
- 6. Panama City Beach
- 7. Pinellas County
- 8. Tampa Hillsborough County
- 9. West Palm Beach Palm Beach County

NON-CONSENSUAL TOWING RATES

The following exhibit shows the established flat rate fee for non-consensual tows by vehicle class.




When summarizing the data from the previous exhibit the average flat rate fee for non-consensual and policedirected tows by class are as follows:

Class A Vehicle: \$127.23
Class B Vehicle: \$190.03
Class C Vehicle: \$335.78
Class D Vehicle: \$395.04

STORAGE FEES

Storage fees vary by city and county. Some municipalities and counties charge a storage rate by class, while others charge a by storage location. Storage locations vary by indoor and outdoor facilities. Additionally, some cities and counties charge fees if the vehicle is over 20 feet long. In the following exhibit, the outdoor storage rate for Class A Vehicles has been shown:

ADMINISTRATIVE FEES

Administrative fees are typically charged after a vehicle is stored for 24 hours and the towing service has complied with requirements of F.S. § 713.78 - Liens for recovering, towing, or storing vehicles and vessels, including execution and mailing of the lien notice. The average Administrative Fee is \$35.00.

ACCEPTABLE FORMS OF PAYMENT

All comparable cities and counties accept cash and money orders however the following cities and counties accept credit card payment as an additional option: Broward County, the City of Key West, the City of Miami, Monroe County, Pinellas County, Palm Beach County, and Miami-Dade County. While these cities and counties have specified acceptance of bank credit cards, no additional information is available at this time discussing policies guiding the acceptance of credit cards.



ANNUAL RATE INCREASE

The cities and counties studied in this report all state that maximum rates may be altered, revised, increased or decreased by commission approval. Broward County specifically stated maximum towing rates are to be reviewed annually and increased by the annual percentage increase in the Consumer Price Index (CPI) or 3%, whichever is less. In fiscal year 2018 the annual CPI increase was 2.3% and the rates were increased by that amount. Again, in fiscal year 2019 the rates increased another 2.3%. While it's important to recognize Broward County mandates these increases in their ordinances, other cities and counties have the authority to approve a rate increase.

SUMMARY

Walker's research reveals the non-consensual and police-directed Class-A towing rates for the City of Miami Beach remains one of the highest within any of the comparable cities and counties listed in this analysis. While Broward County has recently increased their Class-A towing rates to match a 2.3% CPI increase over the past two fiscal years, their maximum allowable towing rate remains at \$137.28 per tow. Other cities and counties within this analysis have not clearly stated they have enacted a recent rate increase. The following summary demonstrates the Class-A towing rates and their acceptable forms of payment for each of the cities and counties listed in the analysis.

I represent Beach Towing Services, Inc., and Tremont Towing, Inc. The purpose of this letter is to clarify certain information contained in the Walker Consultants Police and Parking Department – Maximum Allowable Towing Rates Analysis dated November 5, 2018 ("Analysis").

a. Maximum Allowable Towing Rates

The section of the Analysis concerning the maximum towing rates suffers from two major flaws. First, the Analysis comingles county and municipal maximum towing rates to arrive at the "average" rate. As a result, this "apples to oranges" comparison gives disproportionate weight to individual municipalities which has the effect of artificially suppressing the average rate. A county's maximum towing rates apply countywide except where municipalities have established differing maximum rates for their jurisdictions. With few exceptions, the vast majority of Florida municipalities defer to their county's maximum towing rates.

The Analysis arrives at the average maximum towing rate of \$124.73 for Class A Vehicles by adding the 10 maximum rates and dividing it by the 10 jurisdictions. However, this formula ignores that Palm Beach County² has 39 municipalities, Broward County 31 municipalities, Monroe County 5 municipalities, and Pinellas County 24 municipalities. To arrive at the true average rate of the selected jurisdictions, the maximum rate in each municipality in each county must be considered. Applying this formula, the average maximum towing rate in the Analysis for Class A Vehicles should be \$138.71 (\$14,980.96/108 jurisdictions).

Importantly, several of the selected jurisdictions (i.e. Tampa, Pinellas County, Daytona Beach, and Panama City Beach) are not comparable to Miami Beach. To equitably compare the maximum towing rates in Miami Beach to similar jurisdictions, the analysis should be limited to counties which comprise the South Florida Region, that is, Monroe County, Miami-Dade County, Broward County and Palm Beach County. The average maximum towing rate for the South Florida Region is \$139.95 (\$559.78/4 jurisdictions). The average maximum towing rate applying the applicable county maximum rate to all the municipalities within the South Florida Region is \$142.48 (\$16,100.46/113 jurisdictions).

The second major flaw in the Analysis is it overlooks the fact that Miami Beach imposes a \$30 permit fee for each vehicle towed.³ The permit fee is included in the maximum towing rate and thus results in a true maximum rate of \$110 (before any actual expenses are incurred by the towing companies). Miami Beach's permit fee structure is unique when compared to other jurisdictions. For example, Miami-Dade County (\$15),⁴ Miami (\$30),⁵ and Bal Harbour (\$40)⁶

impose a direct fee on the motorist in addition to the maximum towing rate. Thus, in Bal Harbour, a motorist would be charged the maximum towing rate of \$145, plus the \$40 fee, for a total of \$185, with the towing company retaining one-hundred percent (100%) of the \$145 rate, and the \$40 fee being charged, collected and passed by the towing company to Bal Harbour.

b. Annual Rate Increase

The Analysis inadvertently omits that Miami-Dade County also provides for an automatic annual maximum towing rate adjustment based on the annual percentage change in CPI or 3%, whichever is less.⁷

c. Recommendations

The Analysis should be amended to show (i) that the average maximum towing rate for the South Florida Region is \$139.95; (ii) that the true Miami Beach maximum towing rate is \$110 (below the \$124.73 average rate in the Analysis); and (iii) that, like Broward County, Miami-Dade County has also adopted an automatic annual maximum towing rate adjustment based on inflation. Accordingly, the Analysis should also be amended to recommend that the maximum towing rate for Class A Vehicles should be adjusted by \$30, or alternatively, that, like Miami-Dade County, Miami, and Bal Harbour, the \$30 permit fee should be imposed directly on the motorist thus allowing the towing companies to retain one hundred percent (100%) of the \$140 rate. Dear Mayor and City Commissioners:

I represent Beach Towing Services, Inc., and Tremont Towing, Inc. This letter is in response to the revised Walker Consultants Police and Parking Department – Maximum Allowable Towing Rates Analysis dated November 5, 2018, and revised on December 6, 2018 ("Analysis").

a. Maximum Allowable Towing Rates. Distilled to its essence, the Analysis finds that the true Miami Beach maximum rate for Class A vehicles is \$110 – 13% or \$17 below the "average" rate of \$126.67 of the selected municipalities. Accordingly, the Analysis recommends a rate increase of \$10.50. We support the recommendation to increase the maximum rate; however, we believe it should be further increased for the following reasons. First, a rate increase of \$10.50 would result in a rate of \$120.50, below the "average" rate of \$126.67. Second, the "average" rate is skewed in that it considers distant non-comparable communities contrary to the requirements of the Towing Permit. When the maximum rates are reviewed for an increase, Section 22.L of the Towing Permit requires the City to conduct a survey of maximum rates in "surrounding communities."

Three of the six communities surveyed in the Analysis are *not* surrounding communities – Panama City Beach is 590 miles away, Tampa is 280 miles away, and Daytona Beach is 260 miles away. Importantly, the Analysis offers no explanation why it ignores surrounding communities like Bal Harbour and Surfside. The following is a survey of surrounding *South Florida* communities:

The average maximum towing rate for these South Florida municipalities is \$141.50. This is consistent with the \$139.95 average maximum towing rate for the counties which comprise the surrounding South Florida Region (Monroe County, Miami-Dade County, Broward County and Palm Beach County).

- **b. Permit Fee.** As noted in the Analysis, Miami Beach imposes a \$30 permit fee for each vehicle towed. This fee is included in the maximum rate and results in the towing companies retaining only \$110 of the \$140 rate. We support the recommendation to make the permit fee a pass-through to the motorist. This is consistent with surrounding communities like Miami-Dade County, Miami, and Bal Harbour. For example, in Bal Harbour, a motorist is charged the maximum rate of \$145, plus a \$40 fee for Bal Harbour, with the towing company retaining 100% of the \$145 rate, and the \$40 fee being charged, collected and passed by the towing company to Bal Harbour.
- **c.** Annual Rate Increase. The Analysis omits that like Broward County Miami-Dade County also provides for an automatic annual maximum towing rate adjustment based on the annual percentage change in CPI or 3%, whichever is less.⁵
- **Proposed Amendments to Towing Permit.** Based upon the Analysis and the within, we respectfully request that the Towing Permit be amended to (i) establish the maximum towing rate for Class A vehicles at \$140; (ii) make the City's \$30 permit fee a pass-through imposed directly on the motorist; and (iii) incorporate an automatic annual maximum towing rate adjustment for Class A vehicles based on inflation. Attached hereto as Exhibit A, please find our proposed amendments to the Towing Permit. The proposed amendments are necessary for the local towing industry to continue providing vital public safety services to the City in a safe, timely and efficient manner.

EXHIBIT A

CITY OF MIAMI BEACH ADMINISTRATIVE RULES AND REGULATIONS FOR POLICE AND PARKING TOWING PERMITS

3. PERMIT FEE/MONTHLY BILLING

In addition to the maximum rates that may be charged by the Permittee under Section 22 herein, the City shall charge a Permit Fee of \$35.00 for each vehicle that is towed. Permittee shall charge and collect the Permit Fee on behalf of the City. Permittee shall pay pass to the City a the monthly Permit fee Fee(s) on a monthly basis, in the amount of \$30.00; for each vehicle towed. The monthly Permit fee shall be reduced to \$25.00 for each vehicle towed that receives a Miami Beach Resident Discount pursuant to Section 22.M herein.

The City shall bill Permittee by the 10th of each month for all tows occurring in the previous month. A late charge of \$50.00, plus the greater of (i) eighteen percent (18%) interest per annum, or ii) the maximum rate allowable under Florida law, shall be assessed on all payments received after the 20th day of the billing month.

Payments to the City shall be by check and remitted to the City of Miami Beach Finance Department (Revenue Section). Checks shall be clearly marked "Police Tow" or "Parking Department Tow."

22. MAXIMUM ALLOWABLE RATES

The City Commission shall establish the maximum rates for towing, removal, and storage services provided under the Permit. The maximum rates in this Section 22 are exclusive of the Permit Fee in Section 3 herein. The Permittee shall not charge in excess

of the following maximum allowable rates established by the City (as same may be amended from time to time):

* * * *

- B. Tow Rate Class "A" Tow Truck and Class "A" Car Carrier, including:
 - 1. First 30 minutes at scene

- 2. Unlocking door
- 3. Dropping/hooking up linkage
- 4. Wheel lift equipment
- 5. Use of Dolly

* * * * *

L. Indexing Provision:

The City Manager or his authorized designee may initiate an administrative review of the Maximum Allowable Rates whenever the cumulative change in the Consumer Price Index (CPI – All Urban consumers – US City average – All items – Base Period 1982–84 = 100) (CPI), between the current CPI and the date of the CPI used to establish the last rate adjustment, is greater than five percent (5%). Upon reaching this threshold and, further, following a survey conducted by the City of maximum allowable towing rates for similar services in surrounding communities, and/or an analysis to review the current cost of providing such services, the City Manager or his authorized designees shall prepare a recommendation as to whether there should be an adjustment to the Maximum Allowable Rates; which recommendation shall be subject to final approval by the Mayor and City Commission. The maximum towing rate referenced in Section 22.B herein shall be increased annually by the annual percentage change in the Consumer Price Index (CPI) or by three percent (3%), whichever is less.
