



I was born in New York City in 1940 and received all of my schooling through undergraduate level there. In 1961 I applied to the Peace Corps and it was there that I met my husband, who is a college professor and makes documentaries and independent feature films. We both took graduate degrees at Syracuse University when we left the Peace Corps. My husband had a Fulbright in India and we lived there in the 1970s. We have two children and five grandchildren and semi-retired to Florida 23 years ago, taking advantage of early retirement to pursue other goals. For me, it was devoting more time to writing fiction; I also worked part-time at two area universities, the University of Miami and Barry University. My husband had film and teaching gigs.

I have degrees in English Literature and Library Science, and was the founder and Director of the Reader's Digest General Books Library for over twenty years. I also worked for ABC News and for Citibank, all in New York City. During that time, I wrote for general interest magazines and professional journals, doing book and movie reviews, features, and editing newsletters. I moved to Florida in 1997 and have freelanced at the University of Miami and Barry University; I also do research for a variety of private clients, companies, individuals, e-commerce groups. I was briefly an editor for *Romance Forever*, a romance magazine, and wrote several feature articles, columns, and book reviews for that publication. I have written several articles for *The Regency Plume*, a newsletter for devotees of the Regency genre and for *Solander*, a publication of the Historical Novels Association.

About twenty years ago, I began to write fiction, and was published in a number of little magazines. In 1996, my short story, "By The Rivers Of Babylon," was included in the Herotica 4 anthology, published by Plume. My story was one of only seven selected for the audiocassette and CD-ROM versions of Herotica 4, published by Passion Press. I also wrote an audio book, a short, sweet, contemporary romance set in Kashmir, entitled The Prairie Princess & The Sanskritologist. This story was inspired by actual events during our stay in India.

My short story, "*Belvedere*," was published by Regency Press in August, 1999, in <u>A</u>

<u>Regency Sampler</u>. Regency Press also published my first Regency novel, <u>The Reluctant</u>

<u>Guardian</u>, in January, 2000, in both hardcover and paperback. It is a 72,000 word traditional Regency. <u>Seducing Mr. Heywood</u> is my second Regency novel, and is a sequel of sorts to <u>TRG</u>. It was published in hardcover in June 2002. Large-print versions

of both *The Reluctant Guardian* and *Seducing Mr. Heywood* are available through Chivers.

The Reluctant Guardian received enthusiastic reviews from Library Journal, Publishers Weekly (Starred Review), The Historical Novels Review, and a number of online sources. I have been interviewed by The Miami Herald (2/13/00) and by Writers Digest (September/October 2001 issue), and was recently interviewed by the Syracuse University Alumni magazine. Later this year I will be profiled in Contemporary Authors, a publication of the Gale Group that provides biographies of writers.

<u>Seducing Mr. Heywood</u> received a plethora of outstanding reviews, unusual for romance fiction, in <u>Booklist</u> (Starred Review), <u>Publishers Weekly</u> (reviewed in general fiction section), <u>The Historical Novels Review</u>, and <u>Library Journal</u>. All were in the mid-May 2002 issues of these publications. <u>SMH</u> has been the #1 all-time romance bestseller for its publisher, Five-Star Books. <u>Booklist</u> named <u>SMH</u> one of the <u>Top Ten Romances of the Year</u> in their September 15th, 2002 issue.

I left my part-time position at Barry University in Miami Shores, where I taught online computer searching techniques and manned the Reference Desk – the same position I held at the University of Miami, to devote more time to my writing. I take on occasional freelance research/writing assignments and review literary fiction, mass market, and videos for a number of print and online periodicals. I continue to write, and am now in the midst of the research for a biography of Grace Dalrymple Elliott, Regency courtesan and subject of the new Eric Rohmer film "L'Anglaise et le Duc" (English: "The Lady and the Duke"), a faithful retelling of Mrs. Elliot's memoir, Journal of My Life During the French Revolution. My proposal for this book, tentatively titled My Lady Scandalous, has been submitted by my agent to several New York City publishers. A paranormal novel I wrote a few years ago, The Sicilian Amulet, was purchased by Five-Star Authors and I am working on other fiction manuscripts, both Regency and contemporary.

Update on writing:

My Lady Scandalous was published in 2005 by Simon & Schuster. (I include a copy of that book with this resume.)

My novels <u>The Reluctant Guardian</u> and <u>Seducing Mr. Heywood</u> have been published in several print formats and recently as e-books.

I was a professional reviewer for <u>PublishersWeekly</u> and <u>Library Journal</u> for some 30 years; I currently review books for the <u>miamiartzine</u>, a local arts publication.

Update on community activism:

I have served on the Transportation & Parking Committee (2 ½ years) and on the Historic Preservation Board until term-limited out (a total of 6 years and 2 months). During my

time on these groups I endeavored to consider/hear all applications fairly and to render my most honest judgement. I am no pawn of anyone, much less of developers. I do not take bribes and cannot be bought; I am not a lobbyist; I treasure honesty and concern for our community above all else. I still feel a profound sadness that the City Commission under former Mayor Philip Levine did not take the HPB recommendation to save the historic home designed by Walter De Garmo, 42 Star Island. I am a proud member of Miami Beach United; the Miami Design Preservation League; and the Miami Beach Cinematheque. I am a committed preservationist. It runs in the family; my daughter is a conservator for Historic England, in the UK. I have served as president of my condominium association, The Drake, for 7 years. The Drake is an historic Art Deco building, erected in 1937. I was recently named by Mayor Dan Gelber as a member of the Ocean Drive Blue Ribbon Panel.
