Dear Tom:

This law firm represents 550 Ninth, LLC (the "Applicant") with regard to the above-referenced property (the "Property") within the City of Miami Beach (the "City"). Please let the following serve as the required letter of intent for a Certificate of Appropriateness ("COA") for demolition and design to convert the existing structure from hospital to hotel use (the "Application"). The Applicant previously submitted a similar application for review before the Historic Preservation Board (HPB18-0185), which was withdrawn due to delay with the pending rezoning of the Property.

Description of Property. The Property is approximately 20,870 square feet in size (0.479 acres) and is located at the southeast corner of the intersection of 9th Street and Pennsylvania Avenue. The Property is identified by Miami-Dade County Property Appraiser folio number 02-4203-009-0100. The Property is zoned HD, Hospital District and is improved with a six (6) story hospital facility which was built in 1966. The Property is in the process of being re-zoned to CD-2 Commercial, Medium Intensity District (the "CD-2 District"). The existing structure will be a legally established nonconforming structure in the CD-2 District with height and FAR in excess of what is presently allowed. All of the neighboring properties abutting the Property to the south and east are part of the CD-2 District. The properties neighboring the Property to the west are zoned RM-1, and the properties neighboring the Property to the north are zoned GU and RO.

The Property is located within the Flamingo Park Historic District, and the structure existing on the Property is non-contributing. The Property is also located within the Miami Beach Architectural National Register Historic District. Neighboring the Property to the east is a one-story commercial structure and the properties neighboring the Property to the north, south, and west are all multifamily buildings.

Description of Development Program. The Applicant is proposing to renovate and modernize the existing structure while retaining the nonconforming building and converting it to hotel use through adaptive reuse pursuant to Section 142-456 of the Code. The renovations include restoration of exterior facades and interior spaces and reconfiguration of the units for hotel use. The proposed development will maintain the existing nonconforming floor area and height of the existing structure. The building currently has 88 hospital rooms with a total of 192 beds. The proposed renovations will reconfigure these units and provide additional units to result in providing a total of 110 hotel units.

The first floor will be reconfigured to renovate the interior area on the south end of the Property to serve as the hotel lobby and café with forty (40) seats. The ground level parking area that exists on the northern portion of the Property will be reconfigured to provide for 20 parking spaces to be utilized by valet service, where the cars will be stacked. The rooftop will be renovated to accommodate a pool deck with an indoor bar and cafe. The Applicant has met with the Miami Beach Parking Department to come up with a detailed plan delineating on-street loading pursuant to Section 130-101(C) of the Miami Beach Code of Ordinances (the "Code").

Requests. The Applicant respectfully requests a certificate of appropriateness for demolition and design to convert the existing structure from hospital to hotel use. The Applicant also requests a variance to allow for hotel units as small as 265 square feet where the Code calls for a minimum of 300 square feet pursuant to Section 142-306. The requested variance is necessary to accommodate the preservation and conversion of the existing structure to hotel use in the CD-2 District.

Compliance with COA Criteria. The Applicant's request complies with the Certificate of Appropriateness criteria in that the proposed improvement is compatible with the surrounding properties; and the exterior architectural features and general design, scale, massing and arrangement are analogous to those of neighboring properties. The proposed renovations will beautify the Property and the new rooftop pool deck seamlessly merges into the existing structure.

The proposed renovations are appropriate to and compatible with the environment and adjacent structures, and enhance the appearance of the surrounding properties while prioritizing preservation of the existing structure. The design and layout of the proposed site plan, as well as the new rooftop pool deck addition provides an efficient arrangement of land uses. Overall, the proposed renovations will positively impact the historic character of the neighborhood and district. Accordingly, the Applicant's proposed renovation meets the Certificate of Appropriateness criteria for renovation and design.

Satisfaction of Hardship Criteria. Section 118-353(d) of the City's Code sets forth the hardship criteria for a variance request. The Applicant's request satisfies all hardship criteria as follows:

- (1) Special conditions and circumstances exist which are peculiar to the land, structure, or building involved and which are not applicable to other lands, structures, or buildings in the same zoning district;**

The existing structure on the Property is for hospital use, which is no longer viable or compatible for the area. The zoning change of the Property to CD-2 creates a special condition specific to this Property which compels a conversion of use that will benefit the area and make the Property more compatible with the fabric of the surrounding neighborhood. The unit size variance requested is required in order to effectively convert the existing nonconforming structure into a hotel use while retaining the existing building. The Applicant seeks to retain the existing structure, including the interior wall partitions, which dictate the unit sizes.

- (2) The special conditions and circumstances do not result from the action of the applicant;**

The need for the requested variance directly results from the layout of the existing structure, which was constructed in 1966 for hospital use. The Applicant is not responsible for the layout or construction of the existing nonconforming structure, and the changing fabric of the neighborhood has compelled the scenario where a hospital use is not optimal for the Property and the proposed hotel use will better suit the surrounding area. The Applicant is taking efforts to maximize the hotel unit sizes while using the existing interior wall partitions by reducing the width of the existing hallway corridors to provide more square footage to each unit.

- (3) Granting the variance requested will not confer on the applicant any special privilege that is denied by these land development regulations to other lands, buildings, or structures in the same zoning district;**

Granting the requested variances will enable the Applicant to renovate the existing structure and make a more efficient use of the Property without requiring demolition. The Code allows other similarly situated property owners to seek similar variances to accommodate the preservation of existing structures while allowing for the construction of additional features. The granting of the variance is in line with the purpose and intent of the Code and does not confer any special privilege on the Applicant. The variance is a direct result of the adaptive reuse of the existing nonconforming structure from hospital use to hotel use.

- (4) Literal interpretation of the provisions of these land development regulations would deprive the applicant of rights commonly enjoyed by other properties in the same zoning district under the terms of these land development regulations and would work unnecessary and undue hardship on the applicant;**

A literal interpretation of the provisions of these land development regulations would work an unnecessary and undue hardship on the Applicant. The variance is being requested in order to maintain the existing structure and effectuate the restoration of the Property. The Applicant seeks to retain the legally established nonconforming structure and convert its use to one more compatible with the area. The Applicant is not extending the nonconformity, and wherever possible, is bringing the Property more into compliance with the Code. The unit size variance is needed in order to adequately provide for hotel rooms as part of the adaptive reuse of the existing structure.

- (5) The variance granted is the minimum variance that will make possible the reasonable use of the land, building or structure;**

These request is the minimum necessary in order to allow for the retention and restoration of the existing structure while converting the use to one compatible with the CD-2 District and the fabric of the surrounding neighborhood. In converting the use of the Property, the Applicant is taking all steps possible to minimize this variance by reducing the existing hallway corridor width, and thus adding as much square footage to each unit as possible.

- (6) The granting of the variance will be in harmony with the general intent and purpose of these land development regulations and that such variance will not be injurious to the area involved or otherwise detrimental to the public welfare; and**

The variance will not be injurious to the area or otherwise detrimental to the public welfare. The variance allows for the accommodation of a more compatible use for the surrounding area, which will be consistent with the CD-2 District. Section 142-456 of the Code specifically indicates that when a property is rezoned from HD District, "any building existing on the property may be adaptively reused consistent with the underlying zoning regulations retaining existing nonconforming height, setbacks, floor area ratio and off-street parking." The request is consistent with the purpose, intent and welfare of the Code, and promote the restoration and rehabilitation of existing structures.

- (7) The granting of this request is consistent with the comprehensive plan and does not reduce the levels of service as set forth in the plan. The planning and zoning director may require applicants to submit documentation to support this requirement prior to the scheduling of a public hearing or any time prior to the board of adjustment voting on the applicant's request.**

The variance requested is consistent with the City's comprehensive plan.

Sea Level Rise and Resiliency Criteria. The proposed renovations will make for a more resilient building. The proposed project advances the sea level rise and resiliency criteria in Section 133-50(a) as follows:

- (1) A recycling or salvage plan for partial or total demolition shall be provided.**

The Applicant will provide a recycling or salvage plan during permitting.

- (2) Windows that are proposed to be replaced shall be hurricane proof impact windows.**

The Applicant proposes hurricane impact windows.

- (3) Where feasible and appropriate, passive cooling systems, such as operable windows, shall be provided.**

Operable windows will be provided.

- (4) Whether resilient landscaping (salt tolerant, highly water-absorbent, native or Florida friendly plants) will be provided.**

The Applicant will provide appropriate landscaping at the Property. Proposed species include native and Florida-friendly plants appropriate for the area, including salt tolerant species.

- (5) Whether adopted sea level rise projections in the Southeast Florida Regional Climate Action Plan, as may be revised from time-to-time by the Southeast Florida Regional Climate Change Compact, including a study of land elevation and elevation of surrounding properties were considered.**

The nature of the building that will be preserved and the existing roadway elevation are located below BFE. As a result, the Applicant will look into ways to protect the ground floor during potential flooding events.

- (6) The ground floor, driveways, and garage ramping for new construction shall be adaptable to the raising of public rights-of-ways and adjacent land.**

The nature of the Property that will be preserved is located below BFE. However, an increase in the roadways may be accommodated. Where feasible and appropriate, all critical mechanical and electrical systems will be located above base flood elevation.

- (7) Where feasible and appropriate, all critical mechanical and electrical systems shall be located above base flood elevation.**

Proper precautions will be taken to ensure the critical mechanical and electrical systems are located above base flood elevation.

- (8) Existing buildings shall be, where reasonably feasible and appropriate, elevated to the base flood elevation.**

The Applicant is preserving the facades of the Property. It is not feasible to elevate them.

- (9) When habitable space is located below the base flood elevation plus City of Miami Beach Freeboard, wet or dry flood proofing systems will be provided in accordance with Chapter of 54 of the City Code.**

Proper precautions will be taken to protect the Property from potential floods.

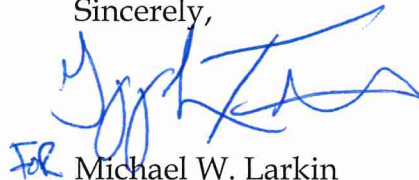
- (10) Where feasible and appropriate, water retention systems shall be provided.**

Given the nature of the proposed development, providing a water retention system is not feasible.

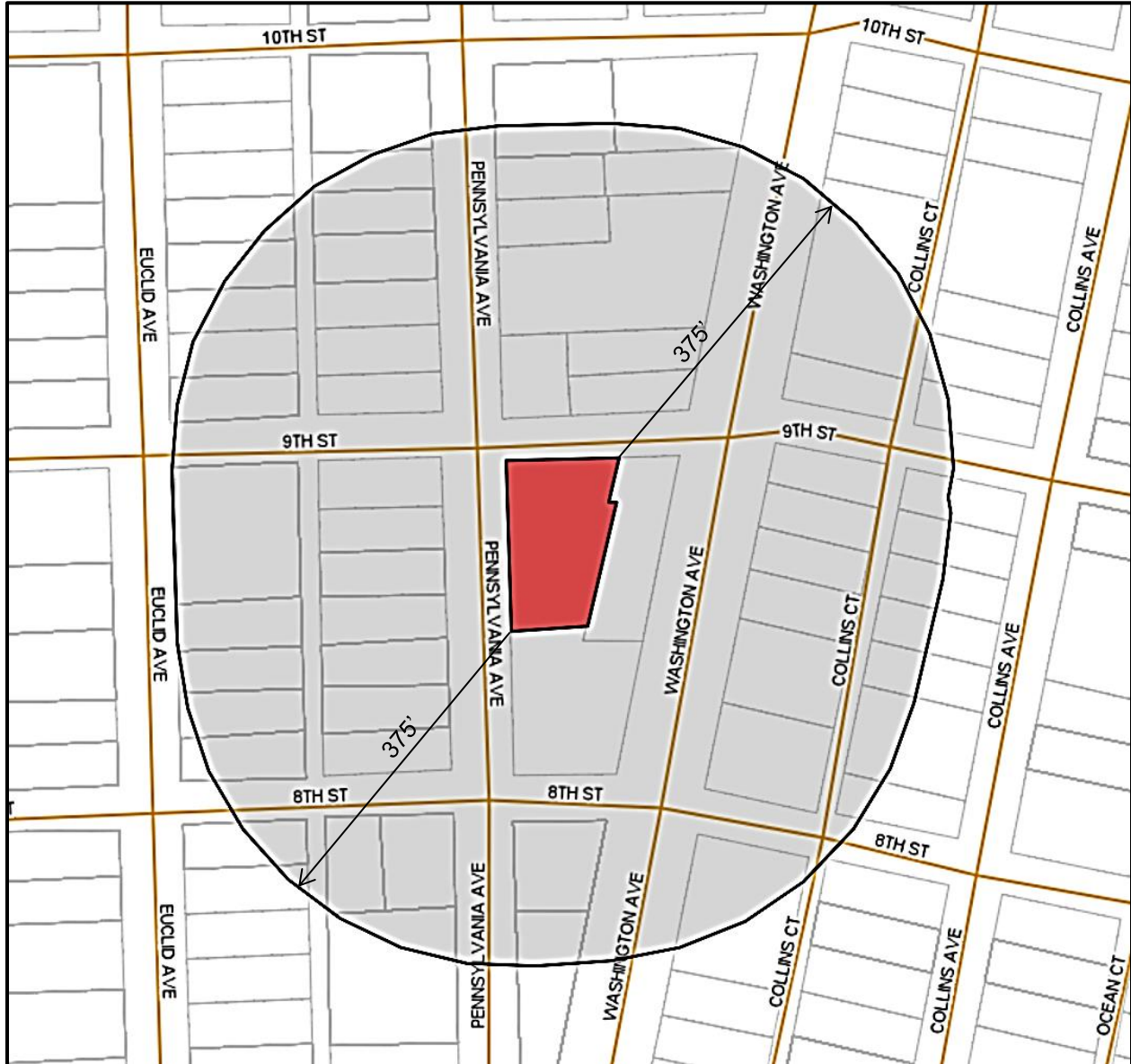

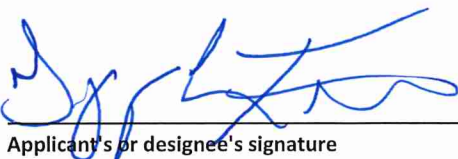
