LIMITED POWER OF ATTORNEY

RE: Versailles Hotel – artistic mural building wrap

Our firm represents 3425 Collins, LLC ("Owner") who is the owner of the Versailles Hotel located at 3425 Collins Ave (the "Property").

During renovations to the Property, the Owner is requesting permission to install an "artistic mural" building wrap on all four sides of the of the Versailles Hotel. The artistic mural is currently installed under the authorization of special event permit #201985, id# 5265. Previously a plain red building wrap ensconced all four sides of the Versailles. A similarly sized artistic mural banner was approved by the HPB (HPB File No. 7604, approved on February 9, 2016) and displayed on the south façade in 2015 and 2016.

The artistic mural depicts a work of art, "Sora Versailles" from the acclaimed American artist Miya Ando. The artwork is a large-scale, site-specific commission that transforms the iconic Versailles within the Faena District, in response to the building's history. Examining perception and permanence, the historic Versailles will be temporarily transformed into the sky itself—the installation investigates one's relationship to time as sunset and sunrise are depicted on the four sides of the building, creating the appearance of the building becoming one with the sky at certain moments of the day, while providing a cinematic and dramatic backdrop to city life at other times of the day and at night. Ando pays homage to the building's original architect Roy France's design philosophy of "let in the air and sun" as she wraps one of Miami's most iconic buildings in clouds during the rehabilitation of the building from within. The work chosen for the banner will serve as a public artwork within the Faena District.

Miya Ando is based in New York City and Los Angeles. Her work has been the subject of international solo exhibitions

including at SCAD (Savannah College of Art and Design), Savannah, GA; Shibuya Seibu, Tokyo, Japan; Sundaram Tagore Gallery, New York, NY; and Lesley Kehoe Galleries, Melbourne, Australia. Her art has also been included in group exhibitions at institutions including the Los

Angeles County Museum of Art (LACMA), CA; San Jose Museum of Art, CA; Bronx Museum, New York, NY; and Queens Museum of Art, New York, NY. Her work is included in the collections of LACMA and the Detroit Institute of Arts, MI, as well as in numerous private collections. Ando has been the recipient of numerous grants and awards, including the Pollock-Krasner Foundation Grant Award and Commission for The Philip Johnson Glass House, New Canaan, CT.

Miya Ando: Clouds is supported, in part, by public funds from the New York City Department of Cultural Affairs in partnership with the City Council, and by the New York State Council on the Arts with the support of Governor Andrew M. Cuomo and the New York State Legislature.

The artistic mural is made from the same material and was installed in the same manner as the red wrap that was previously installed on the building – and those wraps were approved by the City's Building Department via building permit number BC1704852.

The murals are made of an UltraMesh® Premium 328, coated, polyester mesh mural substrate. The mural is perforated so it allows 30% air-flow but keeps out most of the moisture. The product is REACH (Registration, Evaluation, Authorization and Restriction of Chemicals – an EU regulation) compliant.

The size of the murals is as follows: on the south façade: 49' wide and 100' tall, on the east façade: 103' wide and 96' tall, on the north façade: 53' wide and 110' tall, on the west façade: 68' wide and 120' tall. The murals are attached to the façades like the prior red wraps. The murals have 2" reinforced webbing on all sides with heavy duty #5 spur grommets every 18". The murals are installed and secured onto the facades with $\frac{1}{4}$ " x $\frac{2}{4}$ " tap con screws with a $\frac{1}{4}$ " galvanized washer every 3' on center.

The murals and attachment system are rated to withstand a maximum wind of 75 MPH. However, in an abundance of caution the Owner will have the murals removed when winds are forecasted to exceed 50 MPH so that the murals are not blown off of the building.

Because the aggregate size of the artistic mural exceeds 100 square feet, if the HPB approves the murals the City Commission would also have to approve the murals.

We submit that the artistic mural is an interesting and suitable concept for the treatment of the exterior of the building while it is under renovations. The Owner would like to have the artistic mural displayed until such time as the construction on the Versailles proceeds to the point where it cannot be displayed anymore. So while the display time would be temporary, we do not want to put a time-certain end date for the display of the mural. We believe it would make sense to tie the ability of the Owner to display the mural to the validity of the master building permit that the City issued for the Property. In other words, if the master building permit expires then the super graphic would have to be removed. We respectfully request the Historic Preservation Board's favorable review of the request.
