I greatly appreciate your taking the time to review my request for a Variance, on the setback of my property. Please allow me to explain the need for my request.

VARIANCE REQUEST;

- 1. Apply for variance to reduce the required 10' interior setback to proposed 7'-6"**
- 2. Apply for variance to reduce from required 30' front setback for a one story structure attached to 2-story structures to proposed 20'.**

HARDSHIP;

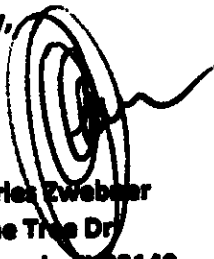
This variance satisfies all hardship criteria included in section 118-353 in the city code and listed below:

- 1. I, as the owner, went into the deal of selling my existing home at 5040 Lakeview Drive, which has been sold and cannot be reversed because of my interest to downside. However, when I decided to purchase this parcel of land and retained my architectural firm I made it very clear that although I wanted to downside I had a minimum requirement. The architectural firm confirmed and verified my requirements with the City of Miami Beach. My needs and requirements were feasible according to the City at the time I purchased the land, retained my architectural firm and demolished the home. The intent of building home from the ground up was the sole reason for the purchase of this land.**
- 2. Other homes in the zoning district are based on the setbacks instituted prior to 2016. If I was notified properly and/or if the demolition permit was linked my proposed building plan, I would have submitted for a master permit in time to share the same setback requirements my neighbors enjoy.**
- 3. As explained above, I am not requesting special privileges. I was granted a demolition permit prior to the setback changes. I demolished to build and now I cannot build as I anticipated because changes were made the setback requirements after my home was issued a demolition permit.**

4. In addition to the new setback changes, the water retention requirements also inflict hardship on my prospective project because it restricts land use. The water retention requirements in combinations with the new setback requirements do not allow me to build a home that will suit my needs.
5. I am requested the minimum variance that will allow me to enjoy my home and fulfill my needs.
6. Thank G-D we were blessed with a large family, including grandchildren. We designed our future home in this area to meet our growing family and religious needs. Any modifications we attempted to make to reduce the size of the home had a direct impact of the common areas, therefore affecting our desire for a true family home that we can enjoy with our children and grandchildren.
7. This goes without saying, and it may not be the sole reason for our hardship, but any change we make at this time would require us to completely redesign the home and incur significant fees.

Finally, although it may not be considered a hardship, I applied for a demolition permit and discussed my plans with the Zoning Department of the City of Miami Beach, prior to the setback changes made in January 2016. Had I have known that these setback changes were being implemented we would have applied for a master permit at the same time I applied for a demolition permit. I appreciate your assistance and look forward to receiving an approval to allow me to building a home that I will be able to share with my beautiful family.

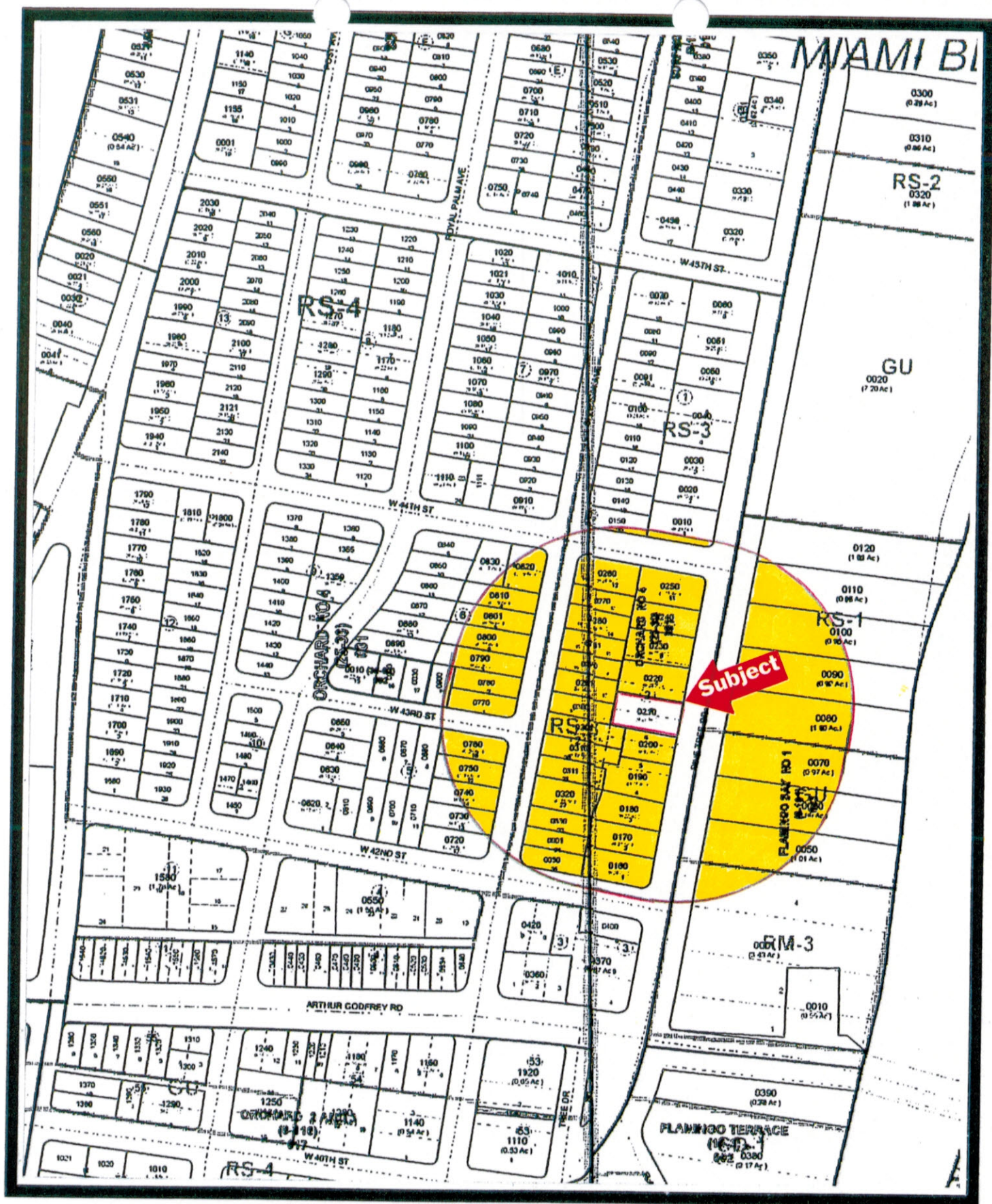
