In October 2006 the City of Miami Beach, in an effort to provide excellent customer service to Resort Taxpayers, created an online web based system giving businesses and individuals the ability to both file their monthly/annual reports and to make payments electronically, by e-check (ACH transfer).

On February 13, 2008, the City Commission approved a change in the Resort Tax Ordinance that required all taxpayers to file and pay online or be subject to a \$25.00 processing fee per return for filing a paper report or paying by check. This requirement will be effective for all returns filed on or after April 1, 2008, for operators remitting \$10,000 or more per <u>year</u> in Resort Tax collections, and for all returns filed on or after July 1, 2008, for operators remitting less than \$10,000 per <u>year</u> in Resort Tax collections.
