A meeting of the Neighborhood and Quality of Life Committee was held on Wednesday, December 16, 2020, at 8:30 a.m. via Zoom. Commissioners in attendance: Micky Steinberg, Steven Meiner, Michael Góngora, and Mark Samuelian. Members from the Administration and the public were also in attendance.

Meeting commenced at 8:30 a.m.

OLD BUSINESS

1. CRIME UPDATE

February 14, 2018 - R9 X Commissioner Gongora Police

Chief Clements updated the Committee on crime trends, arrest data and police planning throughout the City. The Chief reported on Operation Broken Fences, providing the Committee with statistics on arrests and reduction in crime.

Direction: Return to NQLC in February to provide a Spring Break update and discuss technology implementation, financial needs for more technology and report on how technology is helping.

2. DISCUSS RECENT HAZARDOUS USE OF WATERBORNE VESSELS AND UNRULY PASSENGER BEHAVIOR ON MARINAS AND WATERWAYS CITYWIDE

October 14, 2020 - C4 T Commissioner Meiner Police

Commissioner Meiner opened the item and explained his two concerns, the marina, and the waterways.

Chief Clements addressed the Committee, providing data on violations given on our waterways. The Chief explained the No Wake Zones that have been enacted to be able

to control the jet ski operations. MBPD is also working with the City of Miami to control the unruly behavior by the bridges. The Chief stated they would continue to monitor and modify their course of action as needed to rectify the situation. Chief Clements stated that anyone observing loud parties or illegal behavior can report the incident by calling (305) 673-7901.

3. DISCUSSION REGARDING METHODS TO REDUCE EXCESSIVE VEHICULAR SPEEDING IN MIAMI BEACH.

October 14, 2020 - C4 Q Commissioner Meiner Police; Transportation

Commissioner Meiner opened the item and gave a brief overview of the complaints he has received. Specifically, two incidents, one on Normandy Drive by Temples Moses and the other by Terra Beachside Villas on Collins, where cars have swerved onto the sidewalk because of speed when turning,

Chief Clements addressed the Committee and provided an explained how MBPD uses speed measuring devices with an end goal of acquiring compliance.

Commissioner Steinberg explained her efforts in working with the Chief on these issues and discussed the problem is not just enforcement but also street design.

Commissioner Samuelian inquired as to the effectiveness of slow streets. Mr. Gonzalez stated that there were some improvements in the areas with slow street concepts.

Jose Gonzalez, Director of Transportation and Mobility addressed the Committee and explained his Departments efforts to correct these issues. He is working with FDOT to come up with meaningful solutions that will address these recurring issues.

Motion: By acclamation, the Committee motioned for the Administration to take a resolution to the full Commission in January 2021 urging FDOT to add bollards to the problem areas. Also, to add the full Committee as sponsors to the item.

Direction: Return to Committee in 90 days with update on the bollards for the specific problem area of the Normandy Drive by Temples Moses and Terra Beachside Villas on Collins Avenue.

4. DISCUSSION ON THE POLICE CITIZEN RELATIONS COMMITTEE'S MOTION EXPRESSING CONCERN AND REQUESTING ENHANCED REVIEW OF SIDEWALK CAFE PERMIT APPLICATIONS.

October 14, 2020 - R9 H

Commissioner Samuelian and Commissioner Meiner Public Works

Commissioner Samuelian opened the discussion and expressed his concerns regarding sidewalk café permits and the renewal process. He discussed not providing permits for those businesses with several violations and past acts of bad behavior.

Roy Coley, Director of Public Works gave the Committee an overview of the process for obtaining sidewalk café permits and the current situation with violations.

Raul Aguila, Interim City Manager addressed the Committee. He requested the Committee provide the Administration objective criteria that can be used to revoke or deny sidewalk café permits, to the end goal of rectifying the bad behavior from some vendors.

Motion: Move to Commission with recommendation to authorize the Administration to continue approving month to month permits, until new criteria is established that will address businesses with chronic violations. Motioned by Commissioner Meiner and seconded by Commissioner Gongora.

Direction: Return to NQLC in January with amended ordinance addressing specific criteria for denying permits.

5. DISCUSS METHODS TO PROMOTE SEC. 82-384 OF THE CITY CODE ALLOWING, UNDER CERTAIN CONDITIONS, A SIDEWALK CAFÉ TO EXPAND 50 FEET IN BOTH DIRECTIONS FROM RESTAURANT FRONTAGE.

Commissioner Meiner opened the item and explained the importance of promoting restaurants, with sidewalk café permits, ability to expand.

Roy Coley, Director of Public Works addressed the Committee and stated his recommendation is to provide the Neighborhoods Affairs Division the necessary information, for them to notify businesses, regarding their ability to expand their sidewalk café area under the City Code.

Direction: By acclamation, the Committee supports Mr. Coley's recommendation. Remove from NQLC agenda.
