A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, ACCEPTING THE RECOMMENDATION OF THE CITY MANAGER, PURSUANT TO INVITATION TO NEGOTIATE (ITN) 2020-191-ND, FOR MANHOLE, STRUCTURES, AND CURED-IN PLACE REHABILITATION AND INSPECTION SERVICES; APPROVING THE TERMS OF AN AGREEMENT WITH NATIONAL WATER MAIN CLEANING CO, VORTEX INFRASTRUCTURE SERVICES LLC, AND ENVIROWASTE SERVICES GROUP, INC, AS SET FORTH IN EXHIBIT "A" TO THE CITY COMMISSION MEMORANDUM ACCOMPANYING THIS RESOLUTION; AND AUTHORIZING THE CITY MANAGER AND CITY CLERK TO EXECUTE AGREEMENTS WITH NATIONAL WATER MAIN CLEANING CO, VORTEX INFRASTRUCTURE SERVICES LLC, AND ENVIROWASTE SERVICES GROUP, INC.

WHEREAS, on June 24, 2020, the Mayor and City Commission authorized the issuance of Invitation to Negotiate (ITN) 2020-191-ND for Manhole, Structures, and Cured-In Place Rehabilitation and Inspection Services; and

WHEREAS, ITN responses were due and received on July 28, 2020; and

WHEREAS, the City received proposals from the following eight (8) firms: BLD Services, LLC, Envirowaste Services Group, Inc., Granite Inliner, LLC, Hinterland Group, Inc., Insituform Technologies, Inc., Miller Pipeline, LLC, National Water Main Cleaning Co., and Vortex Infrastructure Services, LLC; and

WHEREAS, the proposals from Insituform Technologies, Inc. and Miller Pipeline, LLC were deemed non-responsive for failure to meet the minimum qualifications requirements of the ITN and were not considered further; and

WHEREAS, on July 29, 2020, via LTC # 269-2020, the City Manager appointed the Evaluation Committee (the "Committee"), comprised of Mariana Evora, Civil Engineer II, Public Works Department; Patricia Rendon, Civil Engineer II, Public Works Department; and Mina Samadi, Senior Capital Projects Coordinator, The Office of Capital Improvement Projects; and

WHEREAS, the Committee convened on September 18, 2020 to consider the responsive proposals; and

WHEREAS, the Committee was provided an overview of the project, information relative to the City's Cone of Silence Ordinance and the Government Sunshine Law, general information on the scope of services and a copy of each proposal; and

WHEREAS, the Committee was instructed to score and rank each proposal pursuant to the evaluation criteria established in the ITN; and

WHEREAS, the evaluation process resulted in the ranking of proposers as follows: National Water Main Cleaning Co., as the top ranked proposer; Vortex Infrastructure Services, LLC, as the second ranked proposer; Envirowaste Services Group, Inc., as the third ranked

proposer; Granite Inliner, LLC, as the fourth ranked proposer; Hinterland Group, Inc. as the fifth ranked proposer; and BLD Services LLC, as the sixth ranked proposer; and

WHEREAS, on November 18, 2020, via Resolution No. 2020-31485, the Mayor and City Commission authorized the Administration to enter into simultaneous negotiations with National Water Main Cleaning, Co. (National Water Main), as the top ranked proposer; Vortex Infrastructure Services, LLC (Vortex), as the second ranked proposer; and Envirowaste Services Group, Inc. (Envirowaste), as the third ranked proposer, and further provided that the final selection and of the recommended proposer(s), and contract, be subject to the prior approval of the Mayor and City Commission; and

WHEREAS, City staff proceeded with simultaneous negotiations; and

WHEREAS, City staff created a price list and term sheet and allowed Envirowaste, National Water Main, and Vortex to provide comments on said documents; and

WHEREAS, after obtaining input, staff finalized the term sheet and cost proposal and requested that the firms agree to the terms and provide pricing; and

WHEREAS, City staff reviewed the pricing provided and in order to expedite the required work, while assuring the lowest overall cost, decided to award a push button contract to all three firms; and

WHEREAS, City staff notified the firms that the City would proceed to complete a push button contract and thus requested that a Best and Final Offer ("BAFO") be submitted on or before July 19, 2021; and

WHEREAS, none of the firms submitted a BAFO; and

WHEREAS, City staff drafted the proposed agreement set forth in Exhibit A to the City Commission Memorandum accompanying this Resolution; and

WHEREAS, after reviewing the results of the negotiation process, the City Manager recommends authorizing the Administration to finalize and execute agreements with National Water Main Cleaning, Co., Vortex Infrastructure Services, LLC, and Envirowaste Services Group, Inc., that will assist the City in rehabilitating sewer and stormwater infrastructure.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby accept the recommendation of the City Manager, pursuant to Invitation to Negotiate (ITN) 2020-191-ND for Manhole, Structures, and Cured-in Place Rehabilitation and Inspection Services; approve the terms of an agreement with National Water Main Cleaning Co., Vortex Infrastructure Services LLC, and Envirowaste Services Group, Inc., as set forth in Exhibit "A" to the City Commission Memorandum accompanying this Resolution; and authorize the City Manager and City Clerk to execute agreements with National Water Main Cleaning Co., Vortex Infrastructure Services LLC, and Envirowaste Services Group, Inc.
