I hope that this correspondence finds you well and that the new year is off to a good start.

It has been my privilege to have spoken before you and the Historic Preservation Board on several occasions to advocate on behalf of the preservation of Miami Beach's irreplaceable historic built environment. Your willingness to serve on this important Board and to be an articulate voice in support of the protection of the historic architectural resources of Miami Beach is significant and is appreciated by the residents of the community.

As an architect with a practice that has focused exclusively within the realm of historic preservation for the past 24 years, I have worked on a daily basis with the type of regulations that are codified in the City's Historic Preservation Ordinance. Additionally, I have spent most of that time as a Beach resident and have a personal connection and a deep understanding of the history and evolution of Miami Beach. I strive to utilize this professional expertise, combined with my personal passion for this unique place, to advocate for a position that aims to protect Miami Beach's irreplaceable historic architectural character while accommodating sensitive contextual design. To date, much of my advocacy has been in opposition to projects such as the Ritz-Sagamore that, in my professional opinion, have not been compatible with the historic architectural context.

However, at this time, I am reaching out to you on behalf of a project - the Shore Club - that in my professional opinion, IS compatible with the historic architectural character and context of Miami Beach. My firm, Heritage Architectural Associates, serves as the Historic Preservation Consultant for the project, and we have been involved from the outset.
