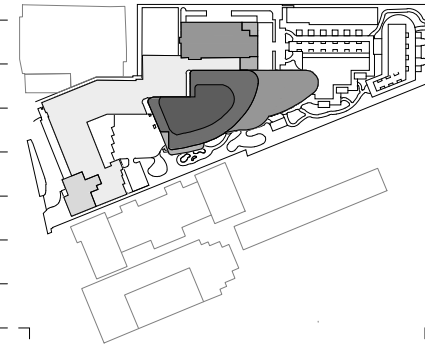


PROPOSED LEVEL 8

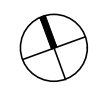


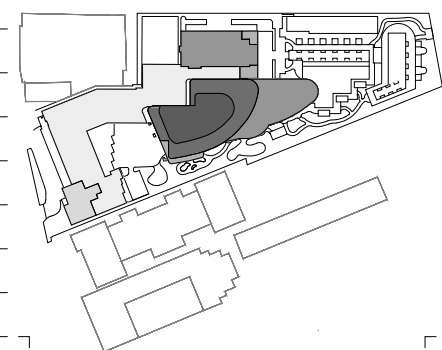
PROPOSED ROOF DECK
