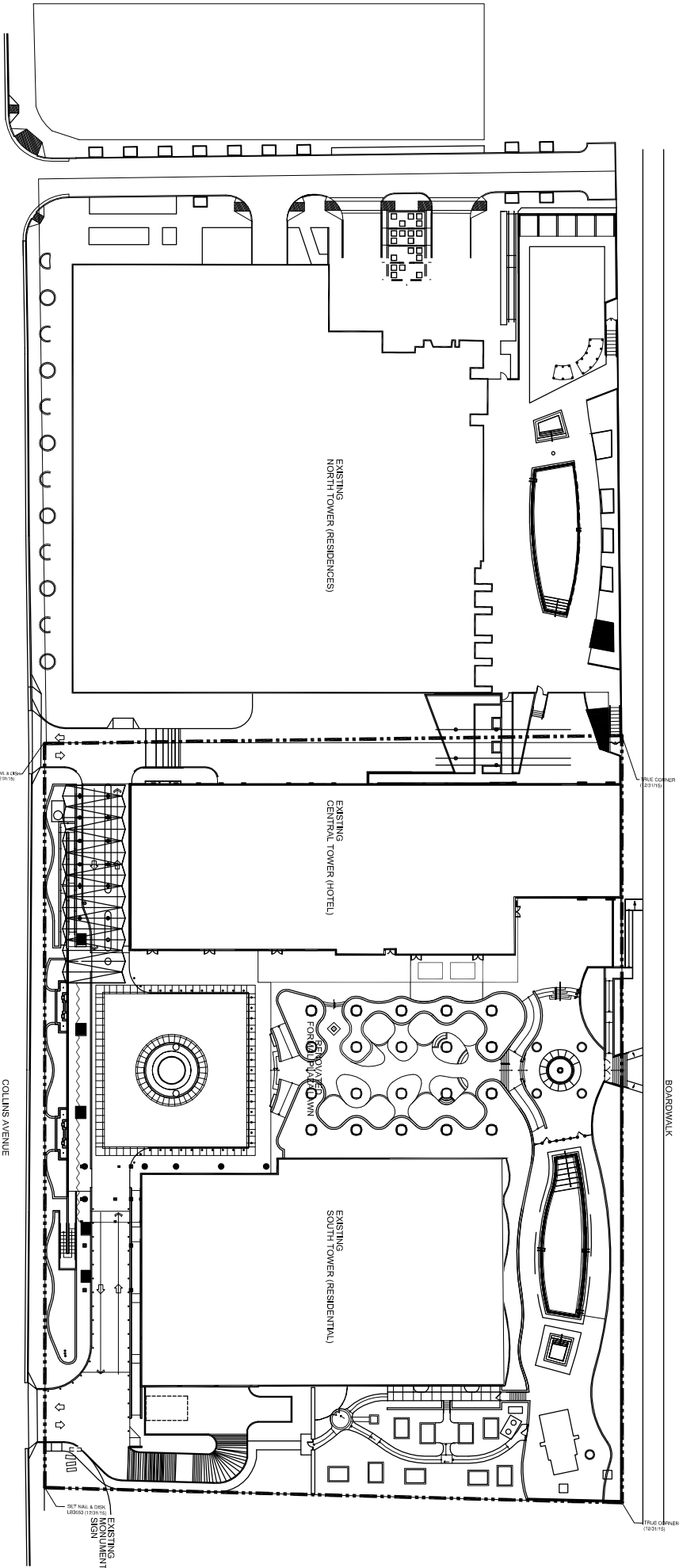
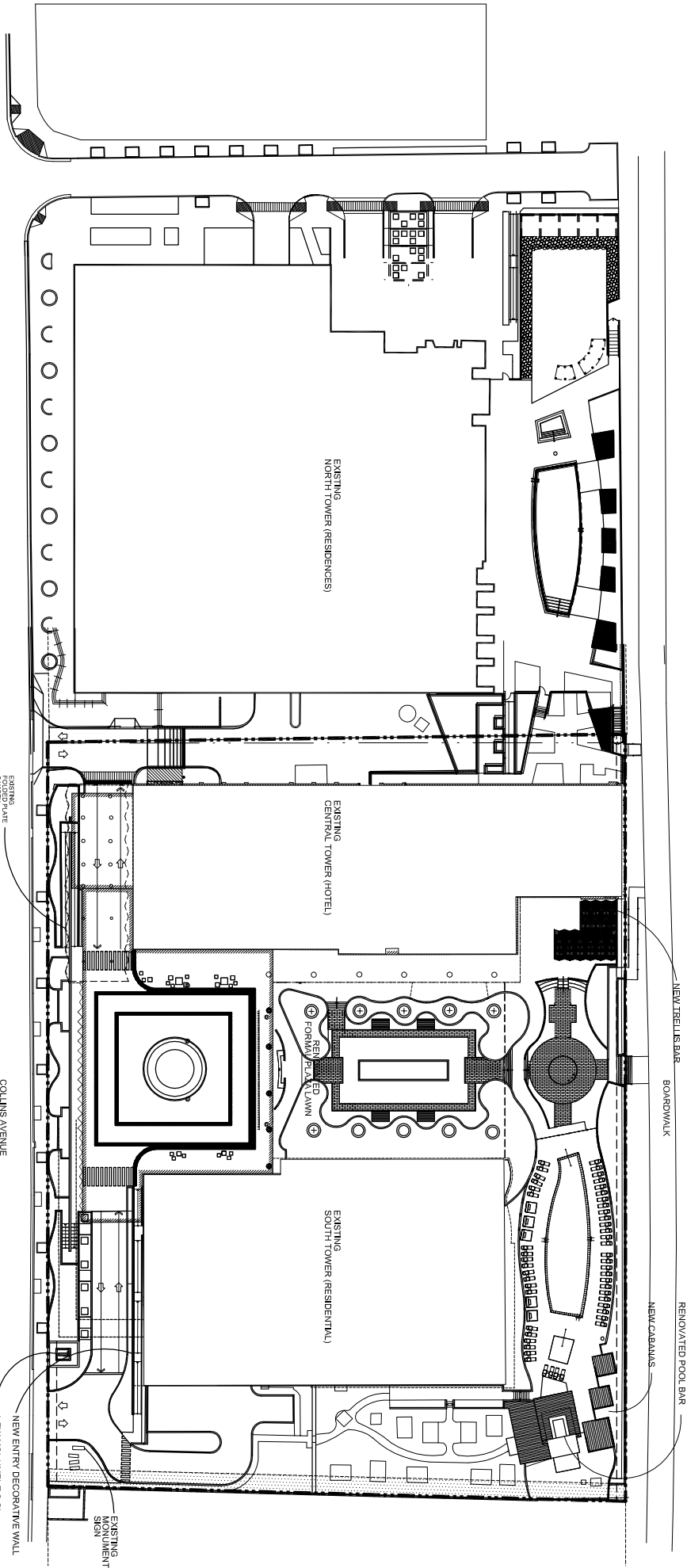




EXISTING SITE PLAN
