This law firm represents Infinity 1200 Ocean Drive, LLC (the "Applicant"), the owner of the above-referenced parcel (the "Property"). Please consider this letter the Applicant's letter of intent in support of a Certificate of Appropriateness for Design and Partial Demolition before the City's Historic Preservation Board ("HPB") required for the redevelopment of the Property.

<u>Property Description.</u> The Property is on the western side of Ocean Drive on the southwest corner of Ocean Drive and 12th Street, and is comprised of approximately 7,322 square feet. The Property contains a three story structure, which currently contains two stories of apartment units and a ground floor restaurant/entertainment venue. The building was originally constructed in 1958. It is located within Ocean Drive/Collins Avenue Local Historic District, and it is designated as a contributing structure in the City's Historic Properties Database. Additionally, it is in the National Register District. The Property is located in the MXE, Mixed Use Entertainment zoning district.

<u>Proposed Development Program.</u> The Applicant seeks to restore and renovate the existing historic structure. Some of the highlights of the renovation will be to make needed, ADA required repairs and upgrades to the ground floor; relocating the apartment entrance from Ocean Drive to 12th Street; façade improvements and a slight expansion of the Ocean Drive stairs. Additionally, we understand that there are existing speakers at the ground floor unit of the building. The tenant, The Palace, has

applied for approval of these speakers and this is scheduled to be considered in December 2016.

The Applicant has retained most of the building but would not be able to retain the grandfathered parking, floor area and setback credits for the existing portions of the building without approval from the HPB because a significant portion of the ground floor slab is being reconstructed, as a necessity. As a result, the Applicant further requests that the board reinstate the historic parking, setback and floor area credits for the existing portions of the building.

<u>Conclusion.</u> The Applicant is proposing a much needed restoration and renovation of this historic structure. The request is modest but necessary in order to make this happen. The development program proposes no additional FAR. As always, we look forward to your favorable review.


