A RESOLUTION OF THE MAYOR AND CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, AUTHORIZING, AS A SOLE SOURCE PURCHASE PURSUANT TO SECTION 2-367(d) OF THE MIAMI BEACH CITY CODE, THE PURCHASE OF SPIRAX SARCO METER SYSTEMS EQUIPMENT, PARTS, SOFTWARE, SERVICE, AND RELATED ITEMS FOR THE CITY'S SATELLITE CITY FLOW METERING SYSTEMS, FROM G-TEC EQUIPMENT SERVICES, LLC, THE EXCLUSIVE AGENT FOR SPIRAX SARCO METER SYSTEMS EQUIPMENT, PARTS, SOFTWARE, SERVICE, AND RELATED ITEMS IN THE CITY'S GEOGRAPHIC REGION.

WHEREAS, the City currently has several Spirax Sarco flow meters installed in the City's water and sewer system that from time to time require parts, service, and replacement equipment to maintain safe and efficient operations; and

WHEREAS, Spirax Sarco, the manufacturer of Spirax Sarco metering products, has notified the City that G-Tec Equipment Services, LLC is its exclusively authorized agent in the City's geographic region for Spirax Sarco brand equipment, parts, and related items, as well as its exclusive service provider; and

WHEREAS, G-Tec Equipment Services, LLC has agreed to offer the City a five (5) percent discount from manufacturer's suggested retail price (MSRP) for new equipment purchases, and an additional two (2) percent discount on invoices that are paid within fifteen (15) days; and

WHEREAS, Section 2-367(d) of the Miami Beach City Code allows for the purchase of goods and services without competitive bidding when only one source for the product or service is evident; and

WHEREAS, the Procurement Department conducted its due diligence and released an Intent to Sole Source (ITS) on December 2, 2016, to publically notify prospective bidders of: 1) the City's intention to seek the required services directly from G-Tec Equipment Services, LLC., Spirax Sarco's exclusive agent; and 2) to allow those bidders who may also be authorized to sell these items to notify the City; and

WHEREAS, no responses to the ITS were received; and

WHEREAS, the Procurement Department will re-evaluate this sole source purchase every three (3) years; and

WHEREAS, the City Manager recommends that the Mayor and City Commission of the City of Miami Beach, Florida, approve, pursuant to Section 2-367(d) of the Miami Beach City Code, the purchase of Spirax Sarco equipment, parts, software, and related items and service, from G-Tec Equipment Services, LLC, the sole authorized agent for these items in the City's geographic region, to maintain safe, efficient and effective operations at the City's flow metering systems where this equipment is installed.

NOW, THEREFORE, BE IT DULY RESOLVED BY THE MAYOR AND THE CITY COMMISSION OF THE CITY OF MIAMI BEACH, FLORIDA, that the Mayor and City Commission hereby approve, pursuant to Section 2-367(d) of the Miami Beach City Code, the sole source purchase of Spirax Sarco equipment, parts, software, service, and related items from G-Tec Equipment Services, LLC, the exclusive agent for these items in the City's geographic region.
